Arrangement for conduct of election.

[1] On 18 November 2025 the Victorian Branch (the **Branch**) of the Australian Hotels Association (the **AHA**) lodged with the Fair Work Commission prescribed information for an election to fill the following office, due to insufficient nominations received in the previous scheduled election (**E2025/35**)¹:

Honorary Treasurer (1)

- [2] The Branch has also advised that prescribed information for the annual election of Branch Delegates to the AHA National Board is due to be lodged soon. Under the AHA rules, nominations for that collegiate election, from members of the Branch Committee of Management,² are to open at least fourteen (14) days prior to the first day of April (i.e. in mid-March 2026). It is requested that election E2025/180 (for Honorary Treasurer) be completed before the opening of nominations for the Delegates to the National Board if at all possible.
- [3] I am satisfied that an election for the abovenamed office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Important Information:

- o In accordance with Rule 19A for Australian Hotels Association (Victorian Branch) the first Council meeting of the newly elected Councillors shall have to power to nominate a financial member of the Association to fill the Vacant offices in accordance with Rule 17 for Australian Hotels Association (Victorian Branch).
- This first meeting of Councillors is scheduled to be held within the first six months of 2026.
- Pending on the decision by the Councillors to proceed with Rule 19A, will then instruct the subsequent procedural requirements to fill the two vacant positions of Executive Board Member (Accommodation Division)
 - Pursuant to the Rules for the Australian Hotels Association (Victorian Branch), the eligible collegiate for the positions of (2x) Executive Board
 Member (Accommodation Division) is the Councillors of the Accommodation Division which currently have six positions vacant.
