Arrangement for conduct of election.

[1] On 4 November 2025 the New South Wales Police Branch (**Branch**) of the Police Federation of Australia lodged with the Fair Work Commission (**Commission**) prescribed information for an election to fill the following offices for a new term of office:

- [2] It is noted that the prescribed information lodged with the Commission requesting this election specified numbers for the Delegates to Branch Biennial Conference and the Ordinary Members of Branch Executive (being a total of 160 Conference Delegates and 16 Ordinary members of Branch Executive respectively).
- [3] The Branch rules provide that the number of Delegates and Executive Committee members are calculated as per Branch rule 52EG(e)(iii), based on the current membership numbers for the abovementioned regions one Conference Delegate per 100 members or part thereof, and one Executive Member per 1000 members. While the Branch has subsequently provided the number of members allocated to each region, as at 11 November 2025, it also noted that these numbers will change, for example with soon-to-graduate student members being deployed to regions, which is expected in the coming weeks and will likely affect the relevant numbers.
- [4] The rules do not specify at which date the figures are to be calculated. I have therefore inferred, in the absence of anything contrary in the rules, that the numbers may be determined as at the date that the roll of voters closes, i.e. seven (7) days before nominations open. As such, this decision notes that the numbers to be elected in each region, for each of these offices, are to be determined in accordance with the rules and that this will be as at the date of the close of the roll of voters.
- [5] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

- 6. If the number of elected representatives is calculated on a formula(s) defined in the rules:
 - a. The rule numbers which specify the formulas are Rule 52EG(e)(iii)(a) regarding Delegates to Branch Biennial Conference. Rule 52EG(e)(iii)(b) regarding Ordinary Members of the Branch Executive.
 - b. The formulas are "Conference Delegates, on a proportionate basis of one per hundred or part thereof, members in each Region" and "Ordinary Executive members, on a proportionate basis of one for up to the first thousand (1000) members, then one for each and every additional one thousand (1000) members, in each Region".
 - c. The information for calculating the formulas is ordinary members in each Region contained in Rule 52EG(e)(iv)E.
 - d. The relevant date for this information is on the closing of the roll, 7 days before the calling of nominations (as determined by the returning officer).
