Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

# **Police Federation of Australia** (E2025/176)

SYDNEY, 17 NOVEMBER 2025

Arrangement for conduct of election.

[1] On 5 November 2025, the South Australia Police Branch (the **Branch**) of the Police Federation of Australia lodged with the Fair Work Commission prescribed information for an election to fill the following offices, due to insufficient nominations received in previous elections (E2024/120)<sup>1</sup> and (E2025/96)<sup>2</sup>:

- [2] After many Branch Annual Conference Delegate roles remained vacant due to insufficient nominations, election E2025/96 succeeded in filling several of those vacancies. This is the second insufficient nominations election for the representatives to the Branch Annual Conference from the Workgroups listed above, which remain vacant.
- [3] The Branch rules stipulate that the delegate entitlement for each Workgroup is determined by the Australian Electoral Commission (AEC) prior to each biennial election and

occurs after the close of the roll of voters for that election and before the calling of nominations. That determination remains in place until the next occurring biennial election for these offices.<sup>3</sup>

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the AEC.
