Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Arrangement for conduct of election.

- [1] On 2 December 2025, the New South Wales Branch (**NSW Branch**) of the Australian Hotels Association (the **AHA**) lodged with the Fair Work Commission prescribed information for an election for Delegates to the AHA National Board for a new term of office.
- [2] The AHA's national rules deal with the election of these offices. Under rule 11.2 of those rules, the NSW Branch is entitled to eight (8) Delegates to National Board by virtue of population. In addition, rule 11.5 provides that 'the President of the Branch shall serve ex officio as a member of the Branch delegation elected in accordance with this Rule and the number of Branch delegates from each Branch will be reduced by one accordingly.' Therefore, an election is sought for:

Delegates to National Board (7)

[3] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
