Arrangement for conduct of election.

[1] On 1 December 2025 the Northern Territory Branch (the **Branch**) of the Australian Education Union (the **AEU**) lodged with the Fair Work Commission (the **Commission**) prescribed information and separately, on 6 January 2026, lodged missing information in relation to an election sought to fill the following offices for a new term of office:

[2] The Branch's rules, as they presently stand, require an annual election to be conducted for the offices of Branch Conference Delegates.¹

Identified non-compliance

[3] Section 182 of the *Fair Work (Registered Organisations) Act 2009* (the **RO Act**) provides that federally organisations and their branches must have their elections for office conducted by the Australian Electoral Commission (the **AEC**) unless they hold an exemption, granted by this Commission under section 186 of the RO Act exempting them from this

requirement. While some Branches of the AEU have been granted exemptions enabling it to use a non-AEC returning officer for some of its elections,² the NT Branch is not one of them.

[4] Elections in organisations and their branches are required to be conducted in accordance with their rules. Section 189(1) of the RO Act obliges organisations and branches to lodge prescribed information in relation to elections that are required to be conducted by the AEC. Failure to lodge prescribed information for an election when one is required under the organisation's rules is a civil penalty provision.³ The Federal Court has imposed significant civil penalties for election-related contraventions.⁴

[5] In early 2025 the Commission reviewed the organisation's rules (the **rules**) and its history of elections as part of a review of election records for registered organisations and their branches, including when their various elections fell due. In relation to the AEU, and in particular this Branch, the Commission was unable to identify any recent election decisions issued by the Commission for Branch Conference Delegates – or indeed, any evidence that these elections had occurred at all.

[6] As indicated above, Commission records do not show any relevant exemptions from AEC-conducted elections which might have authorised the Branch to conduct its own elections i.e. without involvement by the Commission and the AEC. Other Branches seem to have had no difficulty in submitting prescribed information for election of Delegates to Branch Conference or Branch Council,⁵ though the AEU Queensland Branch is currently the subject of compliance action in the form of an enforceable undertaking for its failure to meet election-related obligations in respect of its Branch Council.⁶

[7] In May 2025, Commission staff sought a response from the Branch and the AEU in relation to the Branch's apparent failure to lodge prescribed information for Branch Conference Delegate elections in accordance with the RO Act. The Branch Secretary, Ms Metcalfe, who took up that office in 2022, advised Commission staff that the Branch had historically conducted these elections by an internal nomination process without any involvement by the AEC. Further consultation with the AEU and the Branch ensued, during which all parties acknowledged that continuance of the status quo (i.e. non-AEC elections occurring for what were apparently offices of the Branch) was not an option.

[8] On 1 December 2025, the Branch lodged prescribed information for Branch Conference Delegates (i.e. the lodgement that this election decision deals with). As part of the Commission's assessment of this matter, submissions were sought from the AEU and the Branch including an explanation for previous non-lodgements as well as what, if any, remedial action had been taken (or proposed) to ensure future compliance with Chapter 7 of the RO Act.⁷

[9] On 30 December 2025, the AEU's National Secretary (Nicole Calnan) and the Branch President (Michelle Ayres) lodged separate submissions with the Commission. The AEU's submission stated that a search of AEU and Branch records disclosed no evidence that the relevant elections had ever been conducted by the AEC but had instead been conducted by the

Branch, and that the elections had occurred alongside the local sub-branch non-office positions at the beginning of each year.⁸

[10] The AEU indicated to the Commission that it had consulted with the Branch about steps needed to ensure compliance with the RO Act, identifying two possible options: submitting the prescribed information and proceeding with annual elections via the AEC under the existing Branch rules; or pursuing substantial rule alterations to shift governance responsibilities to a smaller group of office holders. The latter approach apparently contemplated changing the powers of Branch Conference such that Conference Delegates would no longer be officers. The AEU and Branch ultimately decided to submit prescribed information for the 2026 Conference Delegate election (as the current rules require) and proceed with the election under the existing rules, with any rule changes to be considered by the Branch Executive in consultation with members of the Branch.

[11] The AEU National Secretary submitted that there had been no ill intent on behalf of the Branch or to disenfranchise members via internal (non-AEC) ‘elections’ occurring annually. She further advised that a quorum has been present at Branch Conferences and that (purportedly) elected delegates unable to attend had arranged to appoint proxies when required.

[12] Nevertheless, it has been a requirement of the RO Act and its predecessor legislation – for some 40 years now – that the default position for industrial elections is that they are conducted by the AEC. Other AEU branches are, by and large (with the exception outlined above), well aware of this and some have undertaken the proper process of seeking exemptions under section 186 of the RO Act where they wish to have some of their elections conducted by a returning officer other than the AEC.

[13] I am not satisfied that the explanation provided by the AEU and the Branch constitutes a sufficient basis to justify the failure to comply with a statutory obligation. The ultimate statutory responsibility to lodge prescribed information for all elections prescribed under a registered organisation’s rules rests with that organisation. The normal and reasonable expected, therefore, is that organisations (and their branches) will take steps to ensure compliance with election-related requirements set out in the Act and also in instruments pertaining to their own governance, which they themselves have drafted (such as their rules). The fact that the Branch was apparently unaware, across a number of years, that an election for these offices even needed to be conducted by the AEC is deeply concerning. It is apparent that, by virtue of the Branch’s conduct, the AEC has contravened section 189(2) of the RO Act.

[14] I note that once the matter was brought to the organisation’s attention, the National Secretary engaged with the Branch Executive to instigate steps to remedy the non-compliance. I commend the National Secretary for her prompt response.

Information to verify numbers to be elected

[16] When the prescribed information was initially lodged, on 1 December 2025, it included the number of Branch Conference Delegates that the Branch sought to have elected from each

sub-branch. However, it did not include information about the number of members in each sub-branch, which is an essential step because the number of Delegates from each sub-branch is determined using a formula.

[17] Under Branch rule 8(a) the formula provides that:

Each Sub-Branch shall be entitled to representation at Branch Conference by one delegate for each 20 members or part thereof.

[18] The Commission's prescribed information templates,⁹ which endeavour to assist organisations and branches to provide all of the information necessary to enable an election decision to be issued, includes a request to provide:

If the number of elected representatives is calculated on a formula(s) defined in the rules:

- The rule number(s) which specify(s) the formula(s) ...:
- The formula(s) ...
- The information for calculating the formula(s) ... e.g. the number of members ... [You will need to refer to your rules to determine what information is required] ...
- The relevant date(s) for this information ...

[19] When the prescribed information was initially lodged on 1 December 2025, it did not include all of this information, particularly the number of members in each sub-branch.

[20] Schedule 1 of the Branch rules lists the six (6) regions within the Branch,¹⁰ and the sub-branches contained within each region with effect from 30 June 2025. The prescribed information, as originally lodged, included several sub-branches for which the number of Delegates sought was '0'. Consequently, this decision does not list the sub-branches where the number of Branch Conference Delegates to be elected is zero.

[21] In addition, two of the sub-branches listed in the rules – AEU Office Alice Springs and Imanpa School – were not listed in the prescribed information. On 6 January 2026, in response to a query from the Commission, the Branch Secretary confirmed that those two sub-branches have no members and therefore the election of a Branch Conference Delegate from those sub-branches has not been sought.

[22] Information on the number of members in each sub-branch for which an election of Branch Conference Delegates was sought was ultimately provided on 6 January 2026. The number of Delegates listed above in this election decision is for each sub-branch entitled to one or more Delegates, calculated based on the sub-branch member numbers provided by the Branch on 6 January 2026 (i.e. making corrections where the number of Delegates sought in the prescribed information did not match a sub-branch's entitlement under the formula in rule 8(a)).

[23] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the AEC.

[24] The Commission will be engaging further with the AEU and the Branch in relation to the previous failure to lodge prescribed information for Branch Conference Delegate elections, as part of determining an appropriate compliance response.
