- Under the rules of the organisation, the following elections must be held between 1 January and 31 December of THIS YEAR:<sup>4</sup>


Under the rules of the organisation, quadrennial elections are due to be held in 2026 for each of the branches of the AMIEU: the AMIEU QWANT Branch, AMIEU NSW Branch, AMIEU NNSAT Branch, and the AMIEU Victorian Branch.

In fact, each of the four branches of the AMIEU have already held their quadrennial elections, and all four elections were declared between January and March 2026. The list of officeholders attached to this document reflects current officeholders following the declaration of those elections.

The quadrennial elections conducted by the AMIEU NNSAT Branch failed to fill all officeholder positions, leaving two positions vacant. The AMIEU NNSAT Branch recently arranged for the FWC to request the AEC to conduct a further election to fill those two positions and these were declared on or around 5 March 2026.
