*Arrangement for conduct of election.*

[1] On 26 February 2026, the Motor Trades Association of Queensland Industrial Organisation of Employers (the **organisation**) lodged with the Fair Work Commission prescribed information for an election to fill the following offices for a new term of office:

[3] The timing of the lodgement of prescribed information for this election is consistent with the time frame set out in the organisation's rules for the biennial election for this group of Divisional offices and non-office positions.

[4] The most recent election for the Division's roles in this organisation was held in **E2024/125**,<sup>1</sup> with the final stage (Stage 3) of that election concluding in August 2025. The timing of that election was delayed due to rule alterations, which were made to rectify apparent flaws in the organisation's electoral system.<sup>2</sup> In light of that delay, and the requirement that the next election cycle for Divisional officers and non-office positions occur in 2026,<sup>3</sup> the terms of the current Divisional officers and non-office positions elected in E2024/125, have necessarily been truncated by approximately 12 months in order to resynchronise the elections with the timetable in the organisation's rules.

[5] Staff of the Commission have engaged with the organisation about the truncation of terms of those elected in the previous election (E2024/125). The organisation has confirmed that where there has been a requirement to vary the term of an office and/or non-office to preserve the election cycle in the organisation's rules, such as has occurred in this instance, the organisation's members, elected officers and holders of non-office positions, have been made aware of this and updated through organisational committee meetings.

[6] In order to promote consistency and continuity in the organisation's Board, Divisional elections are conducted every two years, with half of the Division's officers and non-office positions elected each year on a rotating basis.<sup>4</sup> I note that it would be impractical, and from the organisation's view undesirable, to delay the conduct of this election (E2026/22), as this would mean that this election and future elections would fall 'out of sync' with the timelines prescribed in the organisation's rules.

[7] I am satisfied that an election for the abovenamed offices and non-offices is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the Australian Electoral Commission.


