Arrangement for conduct of election.

[1] On 10 March 2026, the National Tertiary Education Industry Union (the **NTEU**) lodged prescribed information, and on 24 March and 1 April 2026 lodged amended prescribed information, with the Fair Work Commission for an election to fill the following offices for a new term of office:

National, Divisional and Branch offices as set out in **Attachment A**.

[2] The organisation's rules provide for the terms of offices but do not provide a specific day or month when nominations must open. The opening date for nominations is therefore to be determined by the Returning Officer.

[3] The NTEU rules, specifically Item 8 of Section A in Schedule 4, provide that in the case of direct elections, the General Secretary must, at least seven days before the opening of nominations, distribute an election notice by posting the notice on the organisation's public website and in a publication that is widely distributed among the members who are eligible to vote in the election.

[4] The prescribed information lodged with the Commission for this election indicates that the General Secretary proposes that the Returning Officer (i.e. the Australian Electoral Commission (**AEC**)), open nominations on 20 May 2026. In those circumstances, the election notice would need to be distributed to eligible voting members by no later than 13 May 2026.

[5] In addition to the request for an election for National, Divisional and Branch offices, the prescribed information also requested that the AEC conduct an election under section 187 of the *Fair Work (Registered Organisations) Act 2009* (**RO Act**) for the following non-office positions:

Sub-Branch non-office positions set out in **Attachment B**.

[6] I am satisfied that an election for the abovenamed **offices and non-office positions** is required to be held under the rules of the organisation and, under subsection 189(3) of the RO Act, I am making arrangements for the conduct of the election by the AEC.

NATIONAL TERTIARY EDUCATION INDUSTRY UNION - REQUEST FOR ELECTIONS TO BE HELD.

I, **Damien Cahill**, General Secretary of the National Tertiary Education Industry Union, hereby request, pursuant to Section 189 of the Fair Work (Registered Organisations) Act 2009, that the General Manager arrange for the conduct of this organisation's elections in 2026.

1. Elections are required for those offices specified in the attached table, Attachment B.
2.
 - (a) **The name of each office** (Regulation 138(1)(a)) is specified in the first and second columns of Attachment B. It should be noted that in some cases due to abbreviation or notations, the name given to an office in the Table at Item 2.1 of Schedule 4, is different from the name given elsewhere in the rules. For clarity, especially in calls for nominations from members, the name given generally in the rules is listed in Attachment B.
 - (b) **Where more than one of the offices in respect of which an election is required have the same name** (138(1)(c)) the number of such offices is as specified in the third column of Attachment B, headed "No. Required".
 - (c) **The electorate from which each office is to be elected** (138(1)(d)) is as indicated in the fourth column of Attachment B, headed "Electorate", read in conjunction with the Annexure to Attachment B.
 - (d) **The voting system to be employed** (138(1)(g)) in the conduct of the election is as indicated in the sixth column of Attachment B read in conjunction with the Annexure to Attachment B.
 - (e) **The period during which nominations may be called** (138(1)(e)) is 1 March 2026, to such date as would see the elections declared before the terms of office commence, except that no time is prescribed by the rules in relation to new positions. To be determined by the returning officer.
3. **The terms of office for each office** in the attached table is as specified in the seventh column of the Table at Attachment A. This is consistent with the fact that only offices indicated are full-time salaried offices
4. I have included in Attachment B in the left-hand column in respect of each Branch where it is relevant in determining the number of National Councillors a Branch is to elect, the number of members of the Branch (Rule 29.1). This number is in brackets – e.g. ("897"). The listed number is based, as required by the rules, on the membership numbers according to the best records held by the General Secretary as at the date of lodging this request 10 March 2025 (Rule 29.2).
5. **The date provided for in the rules as the day on which the roll of voters is to be closed** (138(1)(f)) is the seventh day before the date determined for the opening of nominations (Schedule 4, Part B, Item 3).
6. In accordance with Rule 27.2 and Schedule 5, Item 6.6, an election is only requested for the position of Aboriginal & Torres Strait Islander Branch Committee Member at those Branches where, according to the Union's records today, the Union has Indigenous members. I have

caused the records of the Union to be checked in respect of each Branch, and the requests corresponds to the result of that check.

7. Other than the ANU Branch, I can confirm that each of the entities entitled to elect an Additional Divisional Councillor in the ACT Division each has less than 400 members.
8. I can confirm that the University of Tasmania Branch continues to be the only Branch in Tasmania.
9. 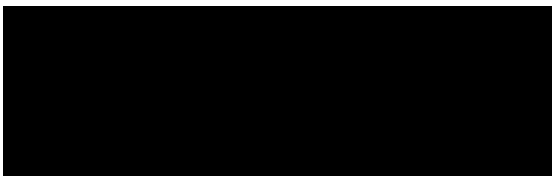
