*Arrangement for conduct of election.*

[2] Branch rule 11 **Composition of Branch Council**, sets out the formula by which the number of Representatives of an Association or Groups of Associations is determined, in accordance with their financial membership.<sup>1</sup>

[3] Paragraphs 6(c) and 6(d) of the prescribed information for this election (**E2026/104**) state, amongst other matters, that the determination of the number of financial members of each Association and Group of Associations shall be 2 April 2026 and 13 June 2026.

[4] Following a request from Commission staff for clarification about the timeframe/s for determining Associations' financial membership referred to in Branch rule 11, the Branch advised that rule 7 **Composition of Branch Conference**, in particular subrule 7(7) applies such that, *where it is necessary to determine a number of financial members of an association, the date shall be a date prescribed by the Branch Council*. The Branch indicated that determining the number of representatives from an Association to Branch Council and to Branch Conference is part of the same process.

[5] As part of its response, the Branch also provided two Reports (November 2025 and June 2026 respectively), in relation to Planning for Council and Conference Entitlements/Representation for 2027-2028, determining the cut-off dates for each Association's financial membership for representatives to the Branch Council and Branch Conference, as 2 April 2026 and 13 June 2026.

[6] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

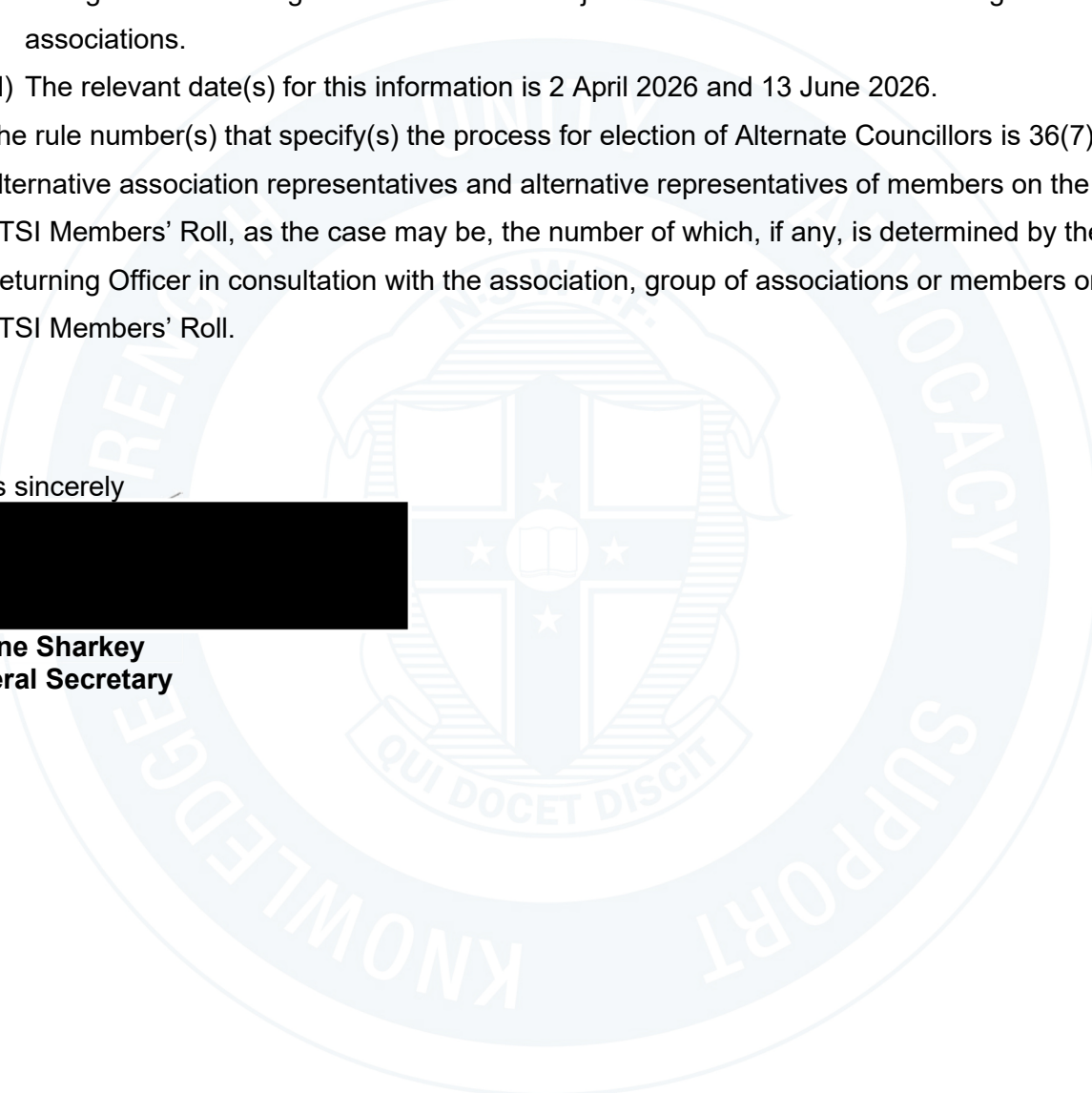
