The returning officer exercised his Powers Under Section 193 to amend the nominations acceptance report to rectify the errors identified by the Union.

Other Matters

Returning Officer actions required (Section 193): Yes

Details: As the rules for Nominators are silent the Returning Officer determined:

1. For all Conferences no time had been determined in the rules for the close of receipt for absent voting requests, the Returning Officer determined it to be 4.00pm (Local Time) the day before the conference.
2. For all Conferences the Returning Officer determined if a ballot is required, there may need to be a ballot period longer than the 45 minute period stated in the rules.
3. For the National Conference, as the rule was silent, the Returning Officer determined eligibility to be a nominator for Assistant National Secretary Food & Confectionery Membership Area to be any delegate to the National Conference from the Food & Confectionery Membership Area.
4. For the National Conference, as the rule was silent, the Returning Officer determined eligibility to be a nominator for Additional Employed delegate to the National Council representing the three smallest states to be any delegate from the three smallest states.

At the Queensland State Conference Nomination Forms originally received contained nominators who weren't eligible to be nominators. The nomination forms were corrected within the nomination period to ensure that nominators were eligible.
