Dear Robert,

Further to your earlier email, after a further examination of the second point you raised in your email of 31 May 2006 regarding the Victorian office of Regional Assistant Secretary - TSA Division / State Organiser it would appear that the office should, as you suggested, be described as "Regional Assistant Secretary" not "Regional Assistant Secretary / State Organiser".

Notwithstanding what is contained in rule 48.23, this would appear to be the consequence of rule 8B(3)(c) which provides that the office of regional assistant secretary is honorary. Further investigation into the calling of the relevant offices also lends support for them being treated differently. The Prescribed Information provided by the AMWU for the elections in E2002/72 indicates that the office of regional assistant secretary was being called as an honorary office only. As a result of that election Mr Charlie Pandolfo was elected into the office. Notably, Mr Pandolfo also currently holds the office of State Organiser for the TSA Division in Victoria however, this position is held by virtue of a separate election in E2002/190 - and Mr Pandolfo's office of State Organiser is not due to go to election until the next election round.

In relation to your query as to the opening of nominations, the date is likely to be around 7 July 2006. Unfortunately to meet this date we will need a finalised copy from the AEC by next week, so that we can mail out to our members. Anything you can do to get move the process along would be much appreciated.

Just a couple of questions regarding the election notice if I may (I'll dispense with the question marks).

**1. I note that Tom Taylor has also resigned from his State Council position. Is that not included because the rules perhaps allow for an appointment to be made given the remaining term of office.**

Mr Taylor's position on State Council has not been included in the prescribed information as elections taking place for positions on State Council at State Conferences of the AMWU have traditionally always been conducted by the relevant AMWU State Returning Officer.

**2. On page 3 of 18, the position of State Organiser now accompanies Regional Assistant State Secretary (TSA - Vic). Is that correct.**

The reference on page 3 to the office of "Regional Assistant **State** Secretary / State Organiser" contains a typographical error in so far as the first inclusion of the word "State" (as bolded) should not be included in a description of the office.

While we note that the office was described simply as "Regional Assistant Secretary" last time the office was called for election in 2002, given rule 48 subrule 23 provides that in the case of the Victorian Branch the Regional Assistant Secretary also holds office as an organiser, we do not consider the addition of the words "/ State Organiser" to be inappropriate in the context of this election and is arguably a more complete description of the office.

**3. On page 4 of 18, State Organisers show (6) positions (Veh - Vic). I note this has increased from (5). How is this figure arrived.**

Rule 27(1)(b) provides that each state may have such number of state organisers as may be determined from time to time by the State Conference subject to the approval of National Council or National Conference.

Prior to the round of elections in 2002, the National Council of the union determined that only 5 of the 6 State Organiser positions in the Vehicle Division in Victoria had approval to go to election.

In September 2004, budgetary circumstances in the Victorian Vehicle Division led National Council to pass a motion giving approval for the position that was not called in 2002 to go to election at the same time as the balance of the State Organisers in the Victorian Vehicle Region.

**4. Would the Delegate to National Conference for TSA - ACT Div be due at this time. Not noted on page 9 of 18.**

We do not believe the office of Delegate to National Conference for the Technical, Supervisory and Administrative Division – ACT Region should be called in this round of elections.

The office of Delegate to National Conference for the Technical, Supervisory and Administrative Division – ACT Region was last called in E2003/69 (the second half of 2003). The office was called at that time as the office had not been filled when it was called in E2002/72 (second half of 2002). Because the vacancy did not arise within a term of office, it is the AMWU's view that the term of office for the current incumbent, Ms Margaret Kennedy, commenced on 1 January 2004 and will expire on 31 December 2007.

**5. Would the Regional Secretary position for TSA - Tas be due at this time. Not noted on page 17 of 18,**

We do not believe the office of Regional Secretary (Hon) – Technical, Supervisory and Administrative Division in the Tasmania Region should be called in this round of elections.

The office of Regional Secretary (Hon) – Technical and Supervisory Division (as it was then described) was called for election in E2005/172 following the resignation of Mr Philip Baker for a 4 year term pursuant to Rule 48 Part C. As a result, the current incumbent, Mr Darren Hanisch, was elected to the office in a term commencing 1 January 2006 and will not face election until 2009.

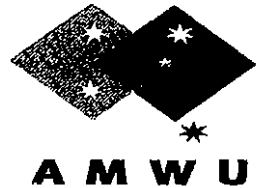

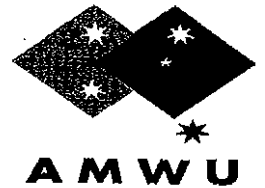
