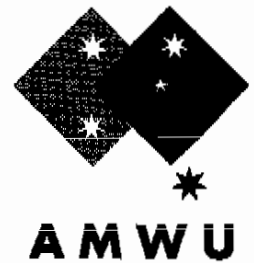

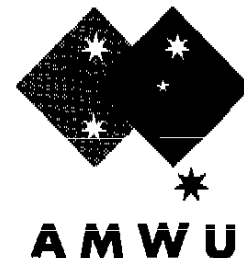

**PRESCRIBED INFORMATION FOR AMWU ELECTIONS

I refer to the Prescribed Information lodged on 3 October 2006, 6 November 2006 and 17 November 2006 by the Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union (AMWU) pursuant to section 189 of Schedule 1 of the *Workplace Relation Act 1996* (the Act) concerning elections due to be conducted in the first half of 2007.

I also refer to the notice of particulars of alterations to the rules lodged by the AMWU on 24 August 2006 [R2006/293] and in particular the rule alterations particularised under the heading "D. Consolidation of Divisional Rules" in paragraph 3 of the notice.

In the circumstances it would appear to be desirable in the interests of clarity if, in relation to the election:

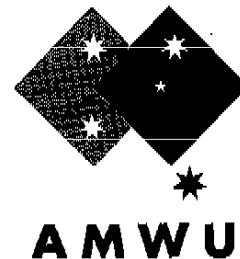

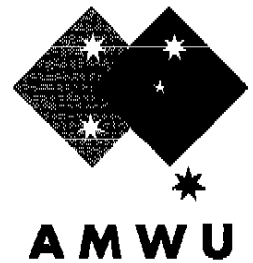

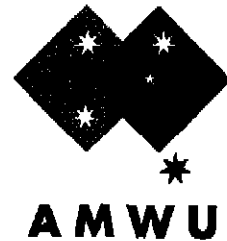
