

Hello Alister,

Further to our conversation earlier, the following are issues noted in the prescribed information (the pi) where I need to call upon your assistance before approaching the Registrar for decision.

As you know the Registrar likes to sight letters of resignation from office. Messrs Bradley and Armenio are referred to in the pi. If you feel that such letters contain private information, please block it out - the Registrar is only interested in name, signature and relevant dates.

Insofar as those other issues are concerned, could I please get your views on the following:

- I note the office of State Organiser Division 9, Metals Division, NSW has not been included in the pi. Is the office due at this time given it was last elected for a 4 year term in 2003?
- Further, I note a person was elected to fill a vacancy in the office of State Organiser Division 5, Metals Division, NSW in 2003. I believe that where such vacancies are filled the rules provide for a fresh 4 year term to the successful candidate. Would this office be due at this time?
- I'm wondering whether Regional President for TSA, ACT might be due at this time given one was elected in 2003 for a 4 year term.
- I believe the Regional Secretary for Printing Division, QLD was elected in 2003 for a 4 year term. Is this office due at this time?
- I'm uncertain how many Delegates to National Conference for Metals, NT were elected in 2003, but it would seem that only one Delegate to National Conference representing Metals, NT has been requested this time. Although a casual vacancy election was held in 2004, I believe the rules provide for 'remainder of term' and therefore if more than one were elected in 2003 then perhaps more than one might be due at this time. Does this sound right to you?
- The office of State Organiser is listed directly under 'Western Australia' in the pi. Is that correct or should it be listed under Metals in that State?
- Under Food and Confectionery, WA I note that the office of Regional Assistant Secretary may have been left out. Does that sound right to you?
- Are we meant to think about Rule 53, Part E in this election given that these persons are elected for a one year term?





PRESCRIBED INFORMATION FOR AMWU ELECTIONS SECOND HALF 2007

I refer to the Prescribed Information lodged on 5 April 2007 by the Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union (AMVU) pursuant to section 189 of Schedule 1 of the *Workplace Relation Act 1996* (the Act) concerning elections due to be conducted in the second half of 2007.

I also refer to your email correspondence of 10 May 2007 regarding the above.

I have considered the comments you made in your email and can respond as follows.

State Organiser – Division 9 (NSW – Metals and Engineering Members)

I can confirm that the position of State Organiser — Division 9 was called in election E2003/69. Mr Harry Delaney was declared elected to that office in an uncontested election. Mr Delaney resigned from the position with effect from 15 July 2005. The casual vacancy led to the office being put to election in E2005/172. Pursuant to Rule 4 Part A subrule 3, the term of office is for a period of 4 years. The AMWU therefore does not seek to call the office at this time.

State Organiser – Division 5 (NSW – Metals and Engineering Members)

I can confirm that the office of State Organiser – Division 5 was also called in election E2003/69. Mr Martin Cartwright was declared elected to that office in an uncontested election. Mr Cartwright resigned from the position with effect from 7 January 2005. The casual vacancy led to the office being put to election in E2005/172. Pursuant to Rule 4 Part A subrule 3, the term of office is for a period of 4 years. The AMWU therefore does not seek to call the office at this time.

Regional President – Technical, Supervisory and Administrative Division -ACT

The AMWU rules no longer provide for a separate Region for the Technical, Supervisory and Administrative Division in the Australian Capital Territory (see Rule 49.7(b)).

Regional Secretary – Printing Division (QLD)

I can confirm that the office of Regional Secretary -- Printing Division (QLD) was called in 2003. On 19 November 2003, Mr Danny Dougherty was declared elected in a contested election. Mr Dougherty continues to hold the office.

The office appears to have been not included in the material provided to the Registrar by oversight. I have attached material formally notifying the Registry of the need for an election to be conducted.

Metals and Engineering Members Delegate to National Conference (NT)

I can confirm that the Australian Electoral Commission called an election for the filling of one office of Metals and Engineering Members Delegate to National Conference (NT) in E2003/69. I note that rule 30.1 provides for a single delegate for metal and engineering members from the Northern Territory.

State Organiser Western Australia

The office of State Organiser - Western Australia is not restricted to the metal and engineering membership (see rule 56.3). It is therefore appropriate that the office is not listed under Metal and Engineering Members heading.

Regional Assistant Secretary – Food and Confectionery Division (WA)

Prior to the extensive amendments to the AMWU Divisional Rules that were certified in November of last year, the union's rules did not require a Region of the Food and Confectionery Division to have an office of Regional Assistant Secretary. I note in particular the reference to "if any" in the previous rule 50.14(a)(v) and rule 50.18 and also to the express provision for a situation where there was no Regional Assistant Secretary in rule 50.18(e).

The Western Australian Region of the Food and Confectionery Division did not have an office of Regional Assistant Secretary. This is reflected in the fact that when other Regional Food and Confectionery positions in Western Australia

were called in E2003/230 and E2003/271 - no election was held for the office of Regional Assistant Secretary.

Following on from the amendments certified in November of last year, the rules now contain a reference to an office of Regional Assistant Secretary.— Food and Confectionery Division (WA) in rule 52.1(c)(v) — although the reference is clearly not consistent with the reference to "if any" in rule 50.27.

I have been advised that the reference to a Regional Assistant Secretary – Food and Confectionery Division (WA) was inadvertent and that no new office was intended to be created. In the circumstances, the union does not seek for the office to be called for election but rather that the relevant bodies within the union be given an opportunity to formally consider amending the rule to remove the ambiguity that exists because of the conflict between rules 50.27 and 52.1(c).

Rule 53 Part E

The elections for these positions are conducted by the Union's National Returning Officer and were last conducted at the Printing Division Federal Conference (as it was then described) in July 2006.

Printing Division Federal Conference / Printing Division National Conference

It was the intention of the AMWU in the rule changes certified on 30 November 2006 to change the name of the "Printing Division Federal Conference" to the "Printing Division National Conference". The renaming was to bring about a consistency in how this type of body is referred to in the rules that deal with the Divisions of the union. Although you have not drawn our attention to specific instances of the use of the name "Printing Division Federal Conference", I can advise that any such references are likely to be unintentional and the union will need to consider updating such references.

- the relevant resignations of Mr Terry Bradley and Mr Frank Armenio that were referred to in the prescribed information lodged on 5 April 2007; and
