



I refer to the prescribed information regarding the abovementioned election that was lodged with Fair Work Australia on 13 July, further information was lodged on 26 August and further prescribed information was lodged on 6 October 2010.

On 14 March 1991 Industrial Registrar O’Shea granted an exemption to the Amalgamated Metal Workers’ Union (as it was then known) from the requirements of subsection 210(1) of the *Industrial Relations Act 1988*<sup>1</sup>:

*“...in respect of the conduct of elections for the following positions (which under the rules of the organisation are required to be elected by and from each State Conference):*

*Delegates to State Council*  
*Delegates to State Administrative Committee*  
*Representatives to National Council*  
*State Vice President*<sup>2</sup>

Since the granting of the exemption, the Amalgamated Metal Workers’ Union has amalgamated with a number of other registered organisations, namely:

- the Association of Draughting Supervisory and Technical Employees (ADSTE);
- the Vehicle Builders Employees Federation of Australia (VBEF);
- the Confectionery Workers and Food Preservers Union of Australia (CW&FPU); and
- the Printing and Kindred Industries Union (PKIU).

During consideration of this matter it has come to my attention that, as a result of those amalgamations, elections for positions other than those covered by the above exemption may



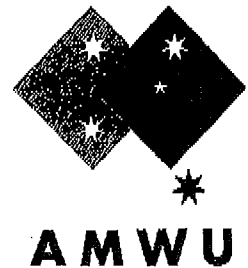

### **Without Prejudice**

Dear Cynthia -

In response to your correspondence of 19 August 2010 in respect of the AMWU's PI lodged 13 July:

#### **1. NSW State Secretary -**

Yes, this was a typographical error. Apologies, the electorate should be all financial members in NSW and ACT;

#### **2. NSW TSA Div Regional Secretary**

On the TSA elections for Regional Secretary in NSW and Queensland, please note the following:

- (i) The Regions for these two areas are defined in Rules 49.7(b) and 49.8 (c) as including the ACT and the NT respectively.
- (ii) Rule 53.14(b) provides that a nominee and a nominator must be members of the relevant Region - we say as defined in Rule 49 above.
- (iii) Rule 53.14(f) provides that the roll of voters is defined by the Region - again - we say as defined in Rule 49.
- (iv) Rule 53.11(c) provides that there will be no election for the extinguished offices of TSA Regional Secretaries in the ACT and the NT - consistent with the construction of points 1 to 3 above.

We see the wording in Rule 8B as consistent with the construction outlined above and with the intent of the Union. We note that there has not been an election for these extinguished positions for many years and that the TSA members in the ACT and the NT have participated in the Regional Secretary elections in the Regions as defined for that same period.

For these reasons, we have not felt it necessary to delete from r.53.11(c) the words "*(other than the Australian Capital Territory Region and the Northern Territory Region)*".

#### **3. QLD TSA Div Regional Secretary**

Please see our comments above in respect of NSW TSA Div Regional Secretary.

#### **4. VIC Vehicle Div Regional Council Committee Members -**

Rule 50.26 provides that regional Councils in regions other than NSW "*must have at least 7 committee members... [etc]...*", and in NSW a number of Award Councillors, District Councillors or General Councillors.

Rule 53.11(f) provides for the election of Committee State Members - Vehicle division and 53.11(g) provides for the election of Award Councillors/District Councillors/General Councillors - Vehicle Division. This is reflected in the provision for these positions at r.53.13.

Nowhere else in rule 53 (or elsewhere in the Rules) is there provision for the election of offices which could be equivalent to those specified at s.50.26 for the Vehicle Division.

This structure reinforces our view that the Committee State members in rule 53 are equivalent to the Committee Members of Regional Councils specified at r.50.26.

The question then arises, as there are slightly different names for the same position, whether the position should be given the title Regional Council Committee member or Committee State Member in the PI. In previous elections, these positions have been known as "Regional Councillor" or "Regional Council Committee Member". For the sake of clarity and consistency, we would propose using the term "Regional Council Committee Member - Vehicle Division"

for Victoria, Qld and SA, rather than the term "Committee State Member", notwithstanding the use of that term in rule 53.

**5. Qld Printing Div delegates to National Divisional Conference -**

Yes, we believe "(number to be determined according to rule)" should be inserted for this office.

**6. Qld Printing Division Regional Councillors representing sub-branches -**

We note that the relevant region for the Printing Division is Queensland and the Northern Territory (r.48.9(c)). We also note that a Regional Council may permit sub-branches etc (r.50.28(f)), which may elect persons to regional Council. However, sub-branches are not mandated, and are not required to cover all sub-regions covered by a Regional Council. We note that the 12 sub-branches do not cover all sub-regions of Qld, in the same way that there are no sub-branches covering NT. That there are Regional Councillors elected under r.53.12 is simply a reflection of the permission to establish sub-branches at r.50.28(f). For this reason, we do not believe that any exception from r.49.8(c) is required in respect of these Regional Councillors.

**7. Printing Division - National Divisional President**

Yes, this is an honorary position, in accordance with r.52.1(c)(i). Nonetheless, the election for this position is specified at r.53.2, in accordance with r.53.5 and Part A of Rule 4.

**8. Victoria - State Organiser - Division 15**

In addition to the points you have raised, we note that there was a further omission from the PI as lodged. The following office should also have been including in respect of Victoria Metals and Engineering:

It is our intention to lodge a supplementary PI for this position in the near future.

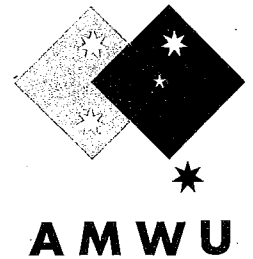
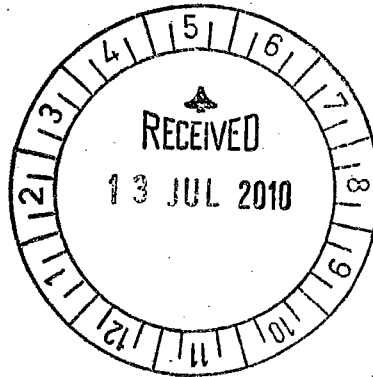
