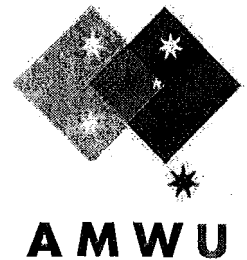

PRESCRIBED INFORMATION FOR ELECTIONS

1. The following offices and / or positions require elections to be conducted by the Australian Electoral Commission for the reasons given in italics. Pursuant to paragraph 138(1)(d) of the *Fair Work (Registered Organisations) Regulations 2009* (the Regulations) the electorate for each office / position is given under the title of the office or position.

2. Pursuant to subregulation 138(1) of the Regulations, Fair Work Australia is advised that for all of the above offices and / or positions in the Rules of the “Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union” known as the Australian Manufacturing Workers’ Union (AMWU) provide that:
 - (a) The returning officer is to determine the opening and closing dates for nominations no later than 26 weeks before the expiration of the term of office;

 - (b) The roll of voters is to be closed 7 days before the opening date of nominations;

 - (c) A collegiate electoral system is to be used in the conduct of the elections;
