I refer to the Post Election Report concerning election E2013/101 received by the Automotive, Food, Metals, Engineering, Printing and Kindred Industry Union (the AMWU) on 6 August, 2013 (the Report).

The Report identifies a difficulty in complying with the rule governing the election of the Technical, Supervisory and Administrative (TSA) Division Delegate to State Council in Tasmania.

For your information, the AMWU is soon to consider rule amendments around the governance of our elections and we will ensure that the matter you have identified here will be rectified.

It is anticipated that the matter will be put to the National Council and National Conference in the not-to-distant future.

The AMWU will make available to its members the part of the Report dealing with the difficult rule and the AMWU's response to it in accordance with the union's obligations under Schedule 1 of the *Workplace Relations Act 1996*.
