ALLEGATIONS OF IRREGULARITIES RECEIVED


Details of written allegations of irregularities, and action taken by AEC:

- Under Section 200 an application to the Federal Court of Australia was made by a candidate for an enquiry in regards to two irregularities which may have affected the result of the election. The irregularities involves giving advice to a candidate which is contrary to Rule 4 Part A 8(k)(ii) and the acceptance of ballot material into the count which is also contrary to this rule. The court confirmed an irregularity had occurred and a court order (VID 290/205 was issued on 26 June 2015 to re-run the ballot starting on 17 August 2015 and to void the declaration of result on 19 May 2015 for the National Divisional Secretary – Vehicle Division.
- A complaint was received alleging the use of union resources. The allegation was investigated with no evidence found to substantiate the allegations.
- A general allegation was raised regarding the collection of ballot material. The Returning Officer requested further information to investigate which received no response.
- Campaign Material - no action taken as this was outside the authority of the Returning Officer with no evidence of an irregularity occurring.
- A complaint was received regarding voter details being used. This was investigated and the Returning Officer was unable to determine the source of this information as there were three requests for the voter roll for this election.

Please find attached the Prescribed Information and Statement of Facts pursuant to section 189 of the *Fair Work (Registered Organisations) Act 2009* concerning elections due to be conducted in the first half of 2015.

This matter has been subject to discussion with Mr David Vaile of your Sydney Office and I would like to further outline those discussions here.

By way of background, the AMWU conducted its first synchronised elections in 2011 and these positions are due to expire on 30 June, 2015 with elections scheduled for early 2015.

The list of Offices in the attached Prescribed Information is based on the Offices that went to election in 2011 subject to the following variations:

1. NSW Vehicle Region

The Regional Council positions in the NSW Vehicle Division have been amended by resolution of the NSW Vehicle Regional Council consistent with Rule 50.26(e)(i) and reflected in the Attachment. (See the resolution of the National Council at Attachment 1)

2. Food and Confectionery Division National Secretary

The position of Food and Confectionery Division National Secretary has been converted to an honorary office to be elected by and from the National Divisional Conference in future. As a result, the position is not listed in the Attachment. (R2014/117)

3. Metals and Engineering Positions

These positions have been amended as a result of recent rule changes in R2014/125. The previous 'Metals and Engineering' positions remain the same in number and electoral process but have been renamed as '*manufacturing membership*' positions.

4. Technical, Supervisory and Administrative Division Positions

7. South Australia – Vehicle Division - Assistant Regional Secretary/State Organiser.



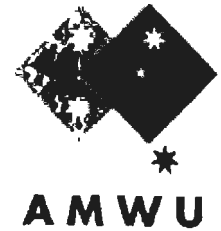


