Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices for New South Wales Branch [E2018/12]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the "Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union" known as the Australian Manufacturing Workers' Union (AMWU) must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;

- the date of the change of office holder;
- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

DECISION

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

"Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union" known as the Australian Manufacturing Workers' Union (AMWU) (E2018/12)

MR ENRIGHT

MELBOURNE, 14 FEBRUARY 2018

Arrangement for conduct of election.

[1] On 29 January 2018 the "Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union" known as the Australian Manufacturing Workers' Union (AMWU) (the organisation) lodged with the Registered Organisations Commission (the Commission) prescribed information for an election to fill a casual vacancy in the following office for the remainder of the term:

New South Wales

Manufacturing Membership

Delegate to State Council (1)

[2] The prescribed information included a letter which indicated that the relevant resignation took effect on and from Friday 10 March 2017. Relevantly, Rule 4 Part B(15)(a) of the AMWU rules provides that:

"As soon as practicable after the occurrence of the vacancy (and no later than 30 days after the occurrence of the vacancy) the State Returning Officer shall determine the opening and closing dates for lodging nominations".

- [3] In those circumstances, staff of the Commission made inquiries with the organisation about whether the prescribed information was lodged before the prescribed day required by regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*.
- [4] On 13 February 2018, Mr Paul Bastian, National Secretary of the organisation, wrote to the Commission noting the requirements of Rule 4 Part A [sic] sub-rule 15(a) of the AMWU Rules while advising that the reason for the delay in lodging the prescribed information was largely due to an incorrect assumption that the vacant office could be filled by appointment. Mr Bastian further explained that the organisation has been placing

significant focus and effort into meeting its legislative requirements in regards to the notification of resignations within 35 days.

[5] In addition, Mr Bastian advised that "in light of this event, we have replicated our national administrative systems for resignations such that it now applies to the filling of vacancies". Furthermore, "We acknowledge the oversight on this occasion but we hope and trust that our record of good and diligent governance on these matters, the outline of factors that contributed to the error as above, and the introduction of new national administrative systems to ensure that such an error cannot occur again, will stand us in good stead".

Application for a later day

- [6] Notwithstanding Rule 4 Part B(15)(a) and that the resignation took effect on 10 March 2017, the organisation applied to lodge the prescribed information by a later day in accordance with section 189(2) of the *Fair Work (Registered Organisations) Act* 2009.
- [7] In considering the application under section 189(2) for lodgement by a later day, I have taken into account the relevant facts and circumstances. I was impressed by the demonstrable candour of the organisation and I accept the oversight explanation. I have taken into account the steps being taken by the organisation to introduce new administrative systems to ensure that future prescribed information is lodged in accordance with its statutory obligations.
- [8] The focus of the Commission is directed toward assisting registered organisations to achieve high levels of voluntary compliance and in my view, the [AMWU's] 'record of good and diligent governance on these matters, the outline of factors that contributed to the error as above, and the introduction of new national administrative systems to ensure that such an error cannot occur again' have, on this occasion, served to stand the organisation 'in good stead'.
- [9] Having regard to the normal and reasonable expectation that registered organisations take steps to ensure that they comply with the time-frame requirements set out not only in the Fair Work (Registered Organisations) Act 2009 but also in instruments or references pertaining to the governance arrangements formulated by organisations themselves, I allow on this occasion a later day for lodgement.
- [10] I am satisfied that an election for the abovenamed office is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Re: <u>E2018/12 – NSW Vacancy Election</u>.

I refer to the above election and the subsequent call between Michael Moutevelis from your office and the AMWU's National Executive Officer, Peter Cozens on 12 February, 2012.

We thank you for bringing this matter to our attention.

The Union wishes to apply for an extension of time for the lodgement of the Prescribed Information in this matter.

We note that Rule 4 – Part A sub-rule 15(a) provides that the Prescribed Information should have been *lodged* "as soon as practicable after the occurrence of the vacancy (and no later than 30 days after the occurrence of the vacancy)".

A number of factors in combination have led us to this position:

- It was incorrectly assumed that the vacant positions arising from the resignation
 of Mr Wallace could all be filled by appointment as his resignation arose in the
 last three quarters of the term of office. This provision applies for his vacated
 National and State Conference positions but not, of course, for his State Council
 position.
- There was also an incorrect assumption that the filling of the position could be done 'as soon as practicable' as is the case in so many other of the Union's elected positions.
- And finally but importantly the National Office of the Union has been placing significant focus and effort on maintaining our systems to ensure that we meet the legislative requirement to notify of resignations within 35 days and we have not, to date, placed commensurate focus on the filling of those vacancies.
