Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices for NSW Branch [E2018/69]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the Fair Work (Registered Organisations) Act 2009 (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the "Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union" known as the Australian Manufacturing Workers' Union (AMWU) must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;

- the date of the change of office holder;
- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Arrangement for conduct of election.

[1] On 16 March 2018 the "Automotive, Food, Metals, Engineering, Printing and Kindred Industries Union" known as the Australian Manufacturing Workers' Union (AMWU) (the organisation) lodged with the Registered Organisations Commission (ROC) prescribed information for an election to fill casual vacancies in the following offices for the remainder of the term:

New South Wales

Manufacturing Membership Delegate to State Council (1) Food and Confectionery Division Delegate to State Council (2) Printing Division Rank and File State Conference Delegate to Administrative Committee (1)

- [2] I note that in the covering letter to the prescribed information, the National Secretary of the AMWU Mr Paul Bastian indicated that the prescribed information was not lodged before the prescribed day as required by regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009*. In his correspondence dated 12 March 2018, Mr Bastian requested an extension of time for the lodgement of the prescribed information.
- [3] In relation to the late lodgement of prescribed information, Mr Bastian stated that "we have instituted a systematic, national review of the administrative procedures required to ensure that vacant positions are filled in a timely manner. Arising from the Review, I regret to advise that as a result, we have uncovered a number of similar circumstances".

- [4] The review referred to by Mr Bastian followed notifications made to the AMWU by the ROC dealt with in E2018/12 with the relevant decision [2018] ROCD 26 issued on 14 February 2018.
- [5] I have taken into account the steps being taken by the organisation to introduce new administrative systems to ensure that future prescribed information is lodged in accordance with its statutory obligations. I have carefully considered the application made by the AMWU and on this occasion I allow on this occasion a later day for lodgement.
- [6] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Re: Prescribed Information for AMWU Elections.

Please find attached the Prescribed Information and Statement of Facts pursuant to section 189 of the Fair Work (Registered Organisations) Act 2009 concerning elections to be conducted due to casual vacancies.

Also attached, please find correspondence sent to the ROC on 13 February, 2018 in which we applied for an extension of time for the lodgement of the Prescribed Information for Election E2018/12. We appreciate that you have granted the extension and set the election in train.

As outlined in this correspondence, we have instituted a systematic, national review of the administrative procedures required to ensure that vacant positions are filled in a timely manner.

Arising from the Review, I regret to advise that as a result, we have uncovered a number of similar circumstances to that which triggered our correspondence of 13 February.

In that light, we again seek an extension of time for the lodgement of the Prescribed Information as attached.

Please find following a brief outline of the circumstances that have led us to this unfortunate position.

Manufacturing Membership – Delegate to State Council

On 29 April, 2016, Mr. Todd Nickle was appointed to fill a vacancy in the office of State Conference Delegate pending an election. While holding that temporary office, Mr. Nickle was elected to the office of State Councillor on 12 May, 2016.

Mr. Nickle did not subsequently stand for the office of State Conference Delegate and, upon the declaration of that election on 7 March, 2017, Mr. Nickle's eligibility for the office of State Councillor fell away.

Unfortunately, due to an administrative oversight, no subsequent steps were taken for an election to be conducted for the vacant office of State Councillor.

Food & Confectionery Division - Delegate to State Council

We have two vacancies in this area for which we seek an extension of time.

The first is in identical circumstances as outlined above with regard to Mr Nickle in that Ms. Haromi (Pepe) Jones was appointed to fill a vacancy in the office of State Conference Delegate pending an election. While holding that temporary office, Ms. Jones was elected to the office of State Councillor on 12 May, 2016.

Ms. Jones did not subsequently stand for the office of State Conference Delegate and, upon the declaration of that election on 7 March, 2017, Ms. Jones' eligibility for the office of State Councillor fell away.

Unfortunately, due to an administrative oversight, no subsequent steps were taken for an election to be conducted for the vacant office of State Councillor.

The other vacancy in this area arises from the resignation of Ms. Beatriz Cullen from the office of State Councillor effective 27 February, 2017. Again, I regret to advise that due to an administrative oversight, no subsequent steps were taken for an election to be conducted for the vacant office of State Councillor.

Printing Division – Rank and File State Conference Delegate to Administrative Committee

Again with the above position, Mr Charles Evans was appointed to fill a vacancy in the office of State Conference Delegate pending an election. While holding that temporary office, Mr Evans was elected to the office of Rank and File State Conference Delegate to Administrative Committee.

Mr Evans did not subsequently stand for the office of State Conference Delegate and, upon the declaration of that election on 7 March, 2017, Mr Evans' eligibility for the office of Rank and File State Conference Delegate to Administrative Committee.

Unfortunately, due to an administrative oversight, no subsequent steps were taken for an election to be conducted for the vacant office of Rank and File State Conference Delegate to Administrative Committee.

As a result of our review of vacant offices arising from our correspondence of 13 February, we have determined that the office of Printing Division Rank and File State Conference Delegate to State Administrative Committee is vacant and we request an extension of time for the lodgement of the Prescribed Information as attached.

Once again, we acknowledge the oversight that has led to this unfortunate situation.

I am confident that the new national systems of oversight in this area which have uncovered these anomalies will help us ensure that they do not happen again.

For your information, I have referred this matter to the Audit, Risk and Investment Committee of the National Council to oversee the implementation of our new systems of national oversight on these matters and to regularly report to the National Council on compliance as required.

We hope that our continued diligence and commitment to good governance will stand us in good stead in your consideration of our application.
