Arrangement for conduct of election.

- [1] On 12 July 2013 the Aged & Community Services Association of NSW & ACT Incorporated lodged with the Fair Work Commission prescribed information in relation to an election. The statement lodged with the prescribed information was not signed by an office holder but by the Chief Executive Officer of the abovenamed organisation.
- [2] On 17 July 2013, the Fair Work Commission wrote to the abovenamed organisation to inform them that under section 189(2) of the Fair Work (Registered Organisations) Act 2009 (the Act) prescribed information must be lodged before the prescribed day, and that as on this occasion the prescribed information had not been lodged before the prescribed day, a request for an extension of time would be required. The Fair Work Commission also informed the abovenamed organisation in the same letter that regulation 138(2) of the Fair Work (Registered Organisations) Regulations 2009 required that a statement lodged with the prescribed information must be signed by an office holder who is authorised to sign the statement. The letter also informed the abovenamed organisation that it appeared that the prescribed information which was lodged was incorrect and amending prescribed information would be required.
- [3] On 22 July 2013, the abovenamed organisation lodged a written request for an extension of time for lodgement in accordance with s.189(2) of the Act. The current President of the Association stated that;

'We apologise for not giving proper notice. We were calculating 2 months before the AGM, not 2 months before the first day when a person may become a candidate.... We therefore request an extension of time, to accommodate this oversight. It will not happen again.'

[4] I note that in 2012, prescribed information for the conduct of a scheduled election for the same abovenamed organisation (E2012/305) was not lodged within the required statutory period resulting in a request for extension of time which was supported in writing by the then President in a letter dated 29 June 2012 in which he stated that:

'I believe the dates set were wrong and it is an administrative error, I have attached the Statement of Notice with the correct scheduled dates for the upcoming election, please allow

for an extension of time. We do apologies [sic] for this inconvenience and have corrected our schedule for all future election correspondence'.

[5] On 22 July 2013, the Aged & Community Services Association of NSW & ACT Incorporated lodged with the Fair Work Commission amended prescribed information in relation to an election for the following offices:

Director (5) (three year term in accordance with Rule 25A)

- [6] I allow for the extension of time up until 22 July 2013 to lodge the amended prescribed information. The statement lodged with the amended prescribed information was signed by an office holder authorised to sign the statement.
- [7] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

I refer to the prescribed information dated 10 July 2013 which was lodged with the Fair Work Commission (FWC) on 12 July 2013 for the conduct of an election for offices of the Aged & Community Services Association of NSW & ACT Incorporated (ACS).

Before an election Decision can be issued the following matters must be resolved.

Firstly, regulation 138(2) of the Fair Work (Registered Organisations) Regulations 2009 (the regulations), requires the statement lodged with the prescribed information to be signed by an office holder authorised to sign the statement. Ms Halliday, you are not an office holder as defined in section 9 of the Fair Work (Registered Organisations) Act 2009 (the Act). Please organise for a statement accompanying the prescribed information to be signed by an office holder.

Secondly, section 189(2) of the Act states that prescribed information must be lodged before the prescribed day, which under regulation 138(3) of the regulations is two months before the first day when a person may become a candidate. Since s.189(2) is a civil penalty provision and the prescribed information for this election was not lodged before the prescribed day, the Delegate of the General Manager requires a written request for an extension of time and providing reasons why the prescribed information was not lodged before the prescribed day. A similar request was made last year in a letter addressed to you on 26 June 2012 in election number E2012/305.

Thirdly, before the Delegate of the General Manager issues a Decision, he or she must be satisfied that an election is required to be held under the rules of the organisation whilst regulation 138(1)(a) of the regulations requires the name of each office for which an election is required. The prescribed information you have lodged refers to an election for four (4) Directors and one (1) Vice President, and that 'an election is required.....as per rule 25A, the annual elections from 2013 onwards will be for five (5) office bearers for a three (3) year term'.

However rule 25A makes no reference to the office of Vice President. Rule 25A is a transitional rule which provided for elections between 2009 and 2011. It states that from 2012 onwards the annual elections will be for five (5) office bearers for a three (3) year term. From my analysis of the ACS rulebook, I believe the prescribed information may need to be amended to request an election

for five (5) Directors, not four (4). It is my understanding that the office of Vice President is then to be elected from the Board of Directors (see reference to rules below).

Rule 14.4 of the ACS rulebook provides that the 'Officers of ACS shall consist of the President......and a Vice President. Rule 14.4 also states that the office of Vice President is 'elected by the Board from among its members', whilst rule 24.1(c) states that 'the elected Directors per 24.1(b) shall elect one of the Board to the position of Vice President' (my emphasis).

If the ACS considers that an election should be held for four (4) directors and one (1) Vice President, rather than five (5) directors, could you point to which rule in the ACS rulebook provides for this.

The current rulebook, in my opinion, when reading rules 14, 24, 25 and 25A together, is confusing and unclear and I would recommend the ACS to consider making rule alterations to remove any ambiguity for future elections.

Once amended and correct prescribed information is lodged we will be in a position to issue a decision for the Australian Electoral Commission.
