Other Matters

Returning Officer actions required (Section 193): Yes Section 193 was applied to the following:

- 1. The rule associated with date and time of withdrawal of a nominations was silent, the Returning Officer applied subparagraph 193(1) (b) (ii) of the Fair Work (Registered Organisation) Act 2009 to determine a closing time for the withdrawal of nomination and the withdrawal period to be aligned with the close of the nomination period.
- 2. The Returning Officer also applied subparagraph 193(1) (b) (ii) of the Fair Work (Registered Organisation) Act 2009 to only accept nominations via email or the AEC's portal and not by hand or postal mail, due to the ongoing COVID-19 risk.
- 3. Rule 19(3) (a) required that the Returning Officer to include postal addresses of all the newly elected representatives on the election notice. Due to privacy concerns, the AEC published names only and did not include postal addresses in the election notice.
- 4. Rule of the Organisation state that the ballot is required to open within 14 days of close of nomination. The Returning Officer deemed this time frame as being insufficient. The Returning Officer applied subparagraph 193(1) (b)(ii) of the Fair Work (Registered Organisation) Act 2009 to extend this period considering key activities including eligibility check, defect remediation period and Christmas closure and therefore opened the ballot within 28 days of the close of the nomination as opposed to 14 days as stipulated in the rules.
- 5. Rules of the Organisation state that nominations are required to open within fourteen (14) days after the office-holders of the committee have been declared elected. The Returning Officer deemed this time frame insufficient. The Returning Officer applied subparagraph 193(1) (b) (ii) of the Fair Work (Registered Organisation) Act 2009 to extend this timeframe to account for the Christmas closure period and opened nominations 21 days after the declaration of election of the office holders of the Committee from all branches, instead of 14 days as stipulated in the rules.

Rule 19(3)m 'On the completion of the election the Returning Officer shall declare the result of the election by sending that result by prepaid post to each of the newly elected representatives;'. Suggest that 'Prepaid Post' be removed to allow for flexibility, an alternative may be 'to send via pre-paid post or by any other electronic means'

Rule 19(3)a '...the Returning Officer shall send by prepaid post to each of the newly elected representatives a list of the names and postal addresses of all the newly elected representatives'. Suggest removing as this already undertaken with the declaration of results from the previous stage or alternatively send the names but removing the need to send postal address as this can raise privacy concerns.
