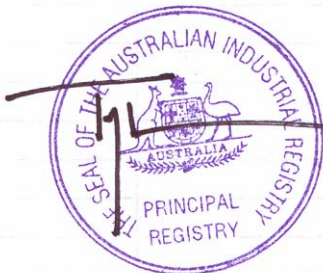
DECISION
