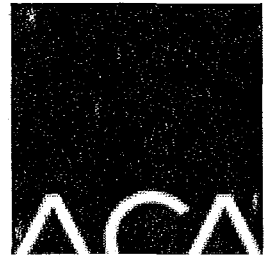

Collegiate Election is by Branch Committee Members.


