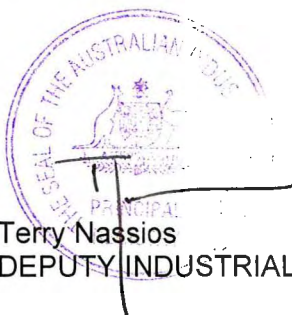

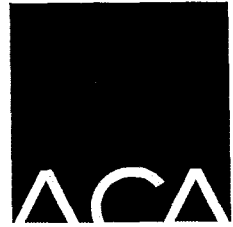
CERTIFICATE

WORKPLACE RELATIONS ACT  
SECTION 271A

My name is Charles Voss. I am currently a practising architect and a member and the branch treasurer of the Association of Consulting Architects, Tasmania Branch. I am acting on behalf of the Branch in this matter and at the request of the Branch Committee of Management.

As provided for under subsection 271(1) of the RAO Schedule and regulation 165 of the Workplace Relations Regulations 2003, I am applying for a Certificate to exempt the Branch from the requirements of the Act relating to financial matters occurring in the year ending 30 June 2007.

In support of the application.

1. The Branch is the state representation of the national body Association of Consulting Architects Australia.
2. The Branch consists of 8 members only for the financial year.
3. Membership fees as the only source of income consists of a major National and a minor Branch component.
4. The branch currently has an account with the Commonwealth Bank – Account N° 06 7000 00258986. Financial transactions are primarily undertaken as collection of membership fees. Most of these membership fees consist of a national component that is forwarded to the national body on receipt of their tax invoice for the same.
5. In previous years, the branch has applied for and was granted exemption from the requirements relating to the formal financial reporting under the Act. The branch finds its self in similar circumstances again this financial year ending June 2007 in that the amounts of funds available to pay for compliance auditing fees is of such magnitude that our branch component of membership fees would need to increase significantly. This step is seen as impractical considering the numbers of members and potential for increased membership in the State.  
The alternative is to close the branch for financial reasons resulting in no local representation of the national body for members or to become affiliated with another State Chapter.

6. The Committee of Management consists of financial members elected by the Branch in accordance with the rules of the organisation and under the management of the AEC. The Committee meets regularly and regulates the affairs of the Branch in a thorough and consistent manner. Minutes of each meeting are kept as records and are available on request.
7. For your information we enclose copies of the 2006/2007 documentation that has been forwarded to members by the Secretary, ACA Tasmania.
8. For completeness and in pursuance to Regulation 165, while the branch expends economic resources (for this financial year - bank fees, admin costs, taxation), it does not rely on another reporting unit of the organisation to expend its own economic resources or incur financial obligations so that the Branch may conduct its activities, and it does not rely on any person or body corporate or trust to expend its own economic resources or incur financial obligations so that the branch may conduct its activities.

Please advise if further information is required to enable you to make a decision.


