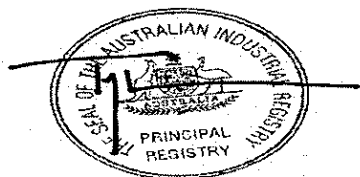

CONDUCT OF ELECTIONS FOR BRANCH/DIVISION COMMITTEES, BRANCH/DIVISION EXECUTIVE OFFICERS, NATIONAL ASSEMBLY AND NATIONAL BOARD MEMBERS.

In accordance with Section 214 of the Workplace Relations Act 1996, concerning prescribed information, I request that you conduct the forthcoming annual election to fill the positions of Branch/Division Committees, Branch/Division Executive Officers, National Assembly and National Board of the Association of Professional Engineers, Scientists and Managers, Australia.

Branch/Divisional Committees (Branch Rule 14)

In accordance with Branch Rule 14 and the Supplementary Branch Rules of the Association, the following Branch/Divisional Committee positions are to be filled by election:

In the case of the **Pharmacists Division**, the Committee shall comprise members elected by and from the following:

- 2 Members resident in New South Wales
- 2 Members resident in Queensland
- 2 Members resident in South Australia
- 2 Members resident in Victoria
- 1 Member resident in Australian Capital Territory
- 1 Member resident in Tasmania
- 4 Members of the Division

In the case of the **Collieries Staff Division**, the eleven (11) members of the Division Committee are elected from and by the financial members from their respective districts as defined in Supplementary Rule 10.1 of the Supplementary Rules of the Collieries Staff Division.

Branch rules specify that certain positions are only to be filled by members from a specific electorate or are to be filled only by members from particular electorates. These rules are designed to ensure we maximise diversity on branch committees. If required, lists of members belonging to these electorates in each state will be provided to enable eligibility to be determined.

As provided by Branch Rule 12.1, one position on each of the Branch Committees listed hereunder shall be open only to women members of the Branch, with the members eligible to vote in the election for this position being financial members of the Branch, and further that the following reserved positions in the Branch Committees specified shall be only open to members defined in Rule 3 other than those members defined in Rule 3.1 or 3.11, and elected by members defined in Rule 3, other than those members defined in Rule 3.1 or 3.11.

Provided that at least one, or in the case of NSW or Victoria, two, of the reserved positions on the Branch Committee must be filled by a member defined in Rule 3.2 and the position to which members shall be elected shall be in the order of reserved positions for members other than those defined in Rules 3.1 or 3.11, non reserved positions and then the position open only for a women member of the Branch.

Provided that in the case of the Collieries Staff Division, the Division Committee of Management shall comprise one member elected by and from each of the Districts of the Division as specified in the Supplementary Rules of the Division.

Division Executive Officers (Branch Rule 14)

In the case of the positions of Branch Executive Officers of the LGEA (NSW) Division, the Telstra and Australia Post Senior Managers Division, the Australian Broadcasting Commission Senior Executives Division, the Architects Division and the Transport Division, nominations are to be called simultaneously

Nominations for the positions of Branch Executive Officers - other Branches, are to be called for after the election of the members of the Branch Committee but not later than the 15th day of December (see Branch Rule 14.2.1)

In accordance with Branch Rule 14, the electorates for the National Assembly positions from Branches/Divisions consists of all financial members of the respective Branch/Division.

As outlined in Federal Rule 16.1.1, there shall be one position on the National Assembly which shall be filled by women members of the Association and a further two positions filled by members as defined in Rule 3.2.

Any National Assembly member may only occupy one National Assembly position and where an eligible member nominates for more than one National Assembly position as provided in these Rules, the position to which that member shall be elected shall be in the order or priority of a position for members eligible under Rule 3.2, a Division defined under Rule 6.2, a Branch defined under Rule 6.1 and then a position for a women member of the Association.

Nominations for the positions on the National Assembly are to be called for after the seventeenth day of September and before the first day of October 2001, and are to be returned to the Returning Officer by the fifteenth day of October 2003, and shall meet the requirements as specified in Branch Rule 14 of the Association's Constitution and Rules.

Should a ballot be required for the positions on the National Assembly, ballot papers, together with information as provided for under the Branch Rule 14.1.3 of the Association's Constitution and Rules, should be sent to each financial member in the electorate for which a ballot is required no later than the fifteenth day of November next ensuing. Ballot papers are then to be returned to the address specified by the Returning Officer so as to ensure to be received no later than the twenty-ninth day of November next ensuing.

The voting system which is to be used for National Assembly elections is the direct voting system.

National Board of Management

The following National Board of Management positions exist as outlined in Federal Rule 18 of the Association's Constitution and Rules:

- National President
- National Senior Vice-President
- National Vice President (3 positions)
- National Secretary

National Treasurer


In the case where at least one woman member nominates for a position on the Board, and no woman is elected to the Board, an additional Vice President position will be created and filled as a casual vacancy with the women candidates who stood for a position on the National Board constituting the candidates to fill the casual vacancy (see Federal Rule 18.3.1).

The electorate for the positions on the National Board consists of members of the National Assembly holding office in accordance with the Constitution and Rules of the Association for the ensuing year (see Federal Rule 18.3)

Nominations for the National Board positions are to be called for before the thirtieth day of November from members of the National Assembly holding office for the ensuing year, and are to be returned to the address specified by the Returning Officer no later than the fifteenth day of January, and shall meet the requirements as specified in Federal Rule 18 of the Association's Constitution and Rules. Members of the National Assembly may nominate for more than one position (but can only be elected to one position). The order of filling such positions shall be National President, National Senior Vice President, National Secretary, National Treasurer, National Vice President. The multiple preferential system of voting (appendix C of the Rules) shall be used for the election of the National Board (see Federal Rule 18.7).

Should a ballot be required for the positions on the National Board, ballot papers, together with information as provided for under Federal Rule 18.4, are to be sent to each member of the National Assembly by the thirty-first day of January next ensuing. Ballot papers should be returned to the Returning Officer not later than the fourteenth day of February next ensuing.
