#### PRESCRIBED INFORMATION - APESMA ELECTIONS

Further to the telephone discussion with the Association's Chief Executive earlier today, I hereby submit the prescribed information in relation to the election of the Committee of Management for the Collieries Staff Division as specified in the Association's Supplementary Rules.

#### Supplementary Rule 5

The Division Committee of Management shall be comprised of eleven (11) members elected by and from the financial members from their respective districts as defined in Supplementary Rule 10.1 herein.

#### Supplementary Rule 10.1

The Districts shall be as follows:

- ➤ Upper Hunter (NSW) all locations in the area bounded by the Western District, the Lower Hunter District and the Central District.
- Lower Hunter (NSW) locations in the area bounded by the Central District, the Western District, the Hunter River from Hexham to Denman and a line running due west from Denham.
- > Central (NSW) all locations in the area bounded by the Southern District, to the west by the Western District and to the north by a line running due east from the

intersections of the New England and Pacific Highways to Hexham and generally west south west from that intersection through the southern point of Ellalong Colliery. This District shall also include members in Tasmania.

- Western (NSW) all locations west of the line running north/south through Katoomba and north of the Southern District and South of the line running east/west through the northern boundary of the Ulan Mine.
- Southern (NSW) all locations in the State south of the line running east/west through Liverpool and inclusive of the ACT.
- Northern (QLD) all mines or establishments north of, and inclusive of, Peak Downs Mine.
- Southern (QLD) all mines or establishments south west of German Creek Mine through to Baralaba and north of Gladstone.
- Western (QLD) all mines or establishments south west of German Creek Mine inclusive of Blair Athol Mine.
- Central (QLD) all mines or establishments south of Peak Downs Mines and through to and inclusive of German Creek Mine but not including Blair Athol Mine.
- Western Australia the whole of the State of Western Australia.

Branch rules specify that certain positions are only to be filled by members from a specific electorate or are to be filled only by members from particular electorates. These rules are designed to ensure we maximise diversity on branch committees. If required, lists of members belonging to these electorates in each state will be provided to enable eligibility to be determined.

As provided by Branch Rule 12.1, one position on each of the Branch Committees listed hereunder shall be open only to women members of the Branch, with the members eligible to vote in the election for this position being financial members of the Branch, and further that the following reserved positions n the Branch Committees specified shall be only open to members defined in Rule 3 other than those members defined in Rule 3.1 or 3.11, and elected by members defined in Rule 3, other than those members defined in Rule 3.1 or 3.11.

Nominations for the National Board positions are to be called for before the thirtieth day of November from members of the National Assembly holding office for the ensuing year, and are to be returned to the address specified by the Returning Officer no later than the fifteenth day of January, and shall meet the requirements as specified in Federal Rule 18 of the Association's Constitution and Rules. Members of the National Assembly may nominate for more than one position (but can only be elected to one position). The order of filling such positions shall be National President, National Senior Vice President, National Secretary, National Treasurer, National Vice President. The multiple preferential system of voting (appendix C of the Rules) shall be used for the election of the National Board (see Federal Rule 18.7).

Should a ballot be required for the positions on the National Board, ballot papers, together with information as provided for under Federal Rule 18.4, are to be sent to each member of the National Assembly by the thirty-first day of January next ensuing. Ballot papers should be returned to the Returning Officer not later than the fourteenth day of February next ensuing.

#### **Election Arising from Amalgamation**

In addition to the elections detailed above, the conduct of an election arising from a yet to be certified amalgamation of the Association and the Professional Officers Association of Victoria will be required. This election will not impact on the elections detailed herein. A further request in relation to this additional election will be submitted upon certification of the proposed amalgamation.
