Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of contested and uncontested offices in matter E2019/99. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Election for six Queensland Sub-Division Committee Members of the Professional Engineers Division – E2019/99

Following the conduct of the above election it was discovered that the counting of votes for this position was not in accordance with the relevant rules of the organisation.

One candidate in this election was ruled ineligible, in accordance with Rule 14.2.7, because they had been elected to a higher position. Ballot papers containing a preference for that candidate were not correctly distributed to the remaining candidates and not included in the final result of the count. Therefore, the declaration of results is incorrect.

Under the provisions of the *Fair Work (Registered Organisations) Act 2009* (the FW (RO) Act) this action constitutes an irregularity as defined in Section 6.

The Australian Electoral Commission is now obliged to take the necessary action to redress this.

Section 193(1) of the FW (RO) Act authorises a Returning Officer to give such directions as the returning officer considers are necessary to prevent an irregularity occurring that would affect the outcome of the election.

Accordingly, the following action will now take place:

1. revoke the declaration of 7 October 2019;
2. revert the election to the point at which the count of the ballot papers was to be conducted;
3. conduct a fresh count of all ballot papers; and
4. make a fresh declaration of results.

A fresh count will be conducted on Tuesday 26 November at 10.30am AEDT in the AEC's Victoria State Office at Casselden, Level 8, 2 Lonsdale Street, Melbourne VIC 3000. Candidates have been invited to have a scrutineer present.

Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices, Stage 1 in matter E2019/99. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. CONDUCT OF ELECTIONS FOR APESMA DIVISION COMMITTEE MEMBERS, DIVISION EXECUTIVE OFFICERS, SUB-DIVISION COMMITTEE MEMBERS, SUB-DIVISION EXECUTIVE OFFICERS, NATIONAL ASSEMBLY AND NATIONAL BOARD MEMBERS

In accordance with S189(1) and (2) of the Fair Work (Registered Organisations) Act 2009 concerning prescribed information, I request that you conduct the forthcoming elections to fill the positions of Division Committee Members, Division Executive Officers, Sub-Division Committee Members, Sub-Division Executive Officers, National Assembly and National Board of the Association of Professional Engineers, Scientists and Managers, Australia.

Electorates for the 2019 Elections

The electorates for the 2019 Elections are those set out in Federal Rule 6.1.

Divisional Committee Members (Division Rule 14)

The Division elections shall be conducted between 1st August and the end of February in the particular year and shall take place in three (3) stages.

The three (3) stages in the election cycles shall be as follows:

Stage 1 – Election of Division and Sub-Division Committees of Management.

Stage 2 – Election of National Assembly and Divisional and Sub-Divisional Executive Officers (except the Professional Engineer Division Executive Officers).

Stage 3 – Election of Professional Engineer Division Executive Officers.

The Returning Officer will determine and notify the relevant dates for the conduct of the elections including but not limited to the opening and closing of nominations, the closing of the roll of voters and other relevant dates in connection with the conduct of any secret ballot(s) in accordance with this Rule.

In accordance with Division Rule 14 and the Supplementary Division Rules of the Association, the following Divisional Committee/Sub-Division Committee member positions are to be filled by election:

NB. In accordance with Rule 12.7 of Appendix “K” – Supplementary Rules – Professional Engineers Division the Professional Engineers Division Committee comprises the President of each Sub-Division Committee and the 3 (three) National Assembly Members elected from Any Subdivision by the electorate of all Financial Members of the Professional Engineers Division.

(a) Professional Engineers Division Sub-Divisions, for each Sub-Division as listed above:

Rule 12.6 of Appendix “K” - Supplementary Rules – Professional Engineers Division: elected by and from all financial members of the relevant Sub-Division

Each Sub-Division Committee shall have a minimum of one person from each gender. If there is no nomination from a particular gender for the Sub-Division Committee then this provision shall not apply.

(b) Professional Scientists Division Committee

As set out in Rule 5.1 of Appendix "J" – Supplementary Rules – Professional Scientists Division - the Division Committee shall consist of 12 persons elected by financial members of the division as follows:

- 1 member elected from and by members resident in QLD
- 1 member elected from and by members resident in NSW
- 1 member elected from and by members resident in ACT
- 1 member elected from and by members resident in VIC
- 1 member elected from and by members resident in TAS
- 1 member elected from and by members resident in SA
- 1 member elected from and by members resident in WA
- 1 member elected from and by members resident in NT
- Plus four (4) other members elected from and by financial members of the Professional Scientists Division.

A minimum of one representative per gender must be elected to the Division Committee. In the event that there is no person from a particular gender elected as set out in Rule 5.1 then if a sole person from a particular gender nominates as (1) of the (4) other members then that person will be deemed to be elected.

(e) Pharmacists Division Committee

As set out in Rule 5 of Appendix “G”- Supplementary Rules of the Pharmacists Division, the Committee shall comprise members elected by and from the following:

- 2 Members elected by and from members resident in New South Wales
- 2 Members elected by and from members resident in Queensland
- 2 Members elected by and from members resident in South Australia
- 2 Members elected by and from members resident in Victoria
- 1 Member elected by and from members resident in Australian Capital Territory
- 1 Member elected by and from members resident in Tasmania
- Plus 4 other Members elected by and from members of the Division

The President, Vice-President, Secretary and Treasurer shall subsequently be elected by and from the members of the Division Committee in accordance with Division Rule sub rule 14.2 on a date to be determined by the Returning Officer

(f) Collieries Staff Division Committee

As set out in Rule 5 of Appendix “H” of the Supplementary Rules of the Collieries Staff Division the eleven (11) members of the Division Committee are elected from and by the financial members from their respective districts as follows:

- New South Wales district - 5 members
- Queensland district - 5 members
- Western Australia district - 1 member

The President, Vice President, and Secretary/Treasurer shall be elected by and from the members of the Division Committee in accordance with Division Rule 14.2.

(g) Managers and Professionals Division

As set out in Rule 6 of Appendix “I” – Supplementary Rules – Managers and Professionals Division the Division Committee shall be comprised of:

- Seven (7) members elected by and from the financial Members of the Division, and
- One (1) member elected by and from Australian Broadcasting Corporation Senior Executive members.

[Division rules specify that certain positions are only to be filled by members from a specific electorate or are to be filled only by members from particular electorates. These rules are designed to ensure we maximise diversity on Division Committees. If required, lists of members belonging to these electorates in each state will be provided to enable eligibility to be determined.]

Nominations for the positions of Division Committee and Sub-Division Committee members are to be called on a date to be determined by the Returning Officer and to be closed on a date to be determined by the Returning Officer (see Division Rule 14.1.1).

In the event of a ballot being held, ballot papers are to be sent to each Division member so as to be received on a date to be determined by the Returning Officer, and returned to the Returning Officer on a date to be determined by the Returning Officer. The roll of voters closes on the 30th day before the opening of nominations (see Division Rule 14.1.6.3)

The voting system to be used is the direct voting system.

The following Division Executive Officer positions and Sub-Division Executive Officer positions (see Rule 14.2 and the Supplementary Division Rules of the Association's Constitution and Rules):

Professional Scientists Division Executive Officers (see Rule 4 of the Federal Rules)

The voting system to be used for these Division Executive Officers is the collegiate electoral system and multiple preferential voting system (see Division Rule 14.2.7 and Appendix 3 to the Rules). The electorates for the positions of Division Executive Officers consist of the Division Committee members holding office in accordance with the Rules of the Association for the ensuing 1 year or 2 year terms in each respective Division (see Division Rule 14.2).

Nominations for the positions of these Division Executive Officers are to be called for after the election of the members of the Division Committee on a date to be determined by the Returning Officer (see Division Rule 14.2.1). Nominations close on a date to be determined by the Returning Officer.

National Assembly

The National Assembly consists of persons elected biennially as provided by Division Rule 14 in the numbers prescribed in Federal Rule 16.2, as follows:

Excluding the National Assembly Members from Any-Sub-Division the total of the number of National Assembly Members to be elected from each Sub-Division must in accordance with Federal Rule 16.1.2.4 must include the Sub-Division President.

Professional Engineers Division - In accordance with Federal Rule 16.1.2.5 a minimum of one National Assembly Member from each gender must be elected. In the event that there is no person from a particular gender who is elected as a National Assembly Member representing a Sub-Division then if a sole person from the particular gender nominates as a National Assembly Member representing Any Sub-Division as specified in Federal Rule 16.2 that person will be deemed to be elected. If there is no nomination received from a particular gender for the position of National Assembly Member from any Sub-Division then the provisions of Federal Rule 16.1.2.5 shall not apply.

In addition, in accordance with Federal Rule 16.1.2.8.2 in order to be eligible for election as a National Assembly Member, a member representing a Sub-Division must also be elected to an office on their relevant Sub-Division Committee.

Professional Scientists Division - In accordance with Federal Rule 16.1.2.6 a minimum of one National Assembly Member from each gender must be elected. If there is no nomination received from a particular gender the provisions of Federal Rule 16.1.2.6 shall not apply.

Managers and Professionals Division – The National Assembly Members representing the Managers and Professionals Division shall in accordance with Rule 8 of Appendix “I” – Supplementary Rules – Managers and Professionals Division comprise:

- (a) The Australian Broadcasting Corporation Senior Executive Division Committee member elected to the Division Committee in accordance with Rule 6.2 of the Appendix “I” – Supplementary Rules – Managers and Professionals Division.
- (b) Additional National Assembly Members elected in accordance with Federal Rule 16.1.

In addition, and in accordance with Division Rule 14.1.4, in order to be eligible for election as a National Assembly Member representing the Managers and Professionals Division a member must be also elected as Division Committee member.

National Assembly Electorates

In accordance with Division Rule 14, the electorates for the National Assembly positions from Divisions are as set out as follows:

- (a) Professional Engineers Division.
 - (i) All financial members of the respective Sub-Division.
 - (ii) Any-Subdivision – All financial members of the Professional Engineers Division.

Federal Rule 16.1.2.8.2 provides that in order to be eligible for election as a National Assembly member, member representing a Sub-Division must also be elected to an office on their relevant Sub-Division Committee.

- (b) For all Divisions excluding the Professional Engineers Division and Divisions listed in (c), (d) and (e) below the electorate in accordance with Division Rule 14 shall consist of all financial members of the respective Division.
- (c) In the case of the Managers and Professionals Division, Division Rule 14.1.4 provides that in order to be eligible for election as a National Assembly member representing the Division must also be elected as a Division Committee Member.

As outlined in Federal Rule 16.1.2.7, there shall be one position on the National Assembly which shall be titled Diversity National Assembly Member and which shall be filled by a financial woman member. The electorate for this position shall comprise all financial women members.

Any National Assembly member may only occupy one National Assembly position and where an eligible member nominates for more than one National Assembly position as provided for in Rule 16.1.2.9 in these Rules, the position to which that member shall be elected shall be in the order or priority of Division, then the Diversity National Assembly member, or in the case of the Professional Engineers Division the order of the filling of positions shall be Any Sub-Division, then Sub-Division and then the Diversity National Assembly Member.

Nominations for the positions on the National Assembly are to be called for on a date to be determined by the Returning Officer and shall meet the requirements as specified in Branch Rule 14 of the Association's Constitution and Rules.

Should a ballot be required for the positions on the National Assembly, ballot papers, together with information as provided for under the Division Rule 14.1.6.3 of the Association's Constitution and Rules, should be sent to each financial member in the electorate for which a ballot is required on a date to be determined by the Returning Officer. Ballot papers are then to be returned to the address specified by the Returning Officer so as to ensure to be received on a date to be determined by the Returning Officer.

The roll of voters closes on the 30th day prior to the opening of nominations (see Division Rule 14.1.6.3)

The voting system which is to be used for National Assembly elections is the direct voting system.

National Board of Management

The following National Board of Management positions exist as outlined in Federal Rule 18 of the Association's Constitution and Rules:

- National President
- National Senior Vice-President
- National Vice President (3 positions)
- National Secretary
- National Treasurer

In the case where at least one woman member nominates for a position on the Board, and no woman is elected to the Board, an additional Vice President position will be created and filled in accordance with Rules 18.3.1.1, 18.3.1.2 and 18.3.1.3.

The electorate for the positions on the National Board consists of members of the National Assembly holding office in accordance with the Constitution and Rules of the Association for the ensuing year (see Federal Rule 18.3).

Nominations for the National Board positions are to be called for on a date to be determined by the Returning Officer from members of the National Assembly holding office for the ensuing year (see Federal Rule 18.3), and are to be returned to the address specified by the Returning on a date to be determined by the Returning Officer, and shall meet the requirements as specified in Federal Rule 18 of the Association's Constitution and Rules. Members of the National Assembly may nominate for more than one position (but can only be elected to one position). The order of filling such positions shall be National President, National Senior Vice President, National Secretary, National Treasurer, National Vice President. The multiple preferential system of voting (Appendix C of the Rules) shall be used for the election of the National Board (see Federal Rule 18.7).
