Prescribed information relating to elections to be held during the year 2006 in accordance with the Rules of the organisation

Elections are required for representatives from the following regions:

#### New South Wales South Australia Tasmania

for a two-year term. The reason for the elections is that the term of each incumbent is due to expire at the time of the Annual General Meeting (AGM).

- These elections are conducted under the direct voting system.
- Elections for the offices of National President, National Vice President and Treasurer will also be required for a two-year term and are conducted under the collegiate voting system. The reason is that the term of each incumbent is due to expire at the time of the AGM.
- Under the Rules, nominations for regional representatives, as defined above, must be called for not less than 50 days in advance of the date fixed the AGM of the Association, and close not later than 30 days from the date of the AGM.
- Under the Rules, nominations for the respective offices of National President, National Vice President and Treasurer are to be called for within seven (7) days of the declaration of election of the three regional representatives by the returning officer forwarding a letter to all board members. Closing date for nominations shall be not less than 14 days after the date of the notice calling for such nominations.
- Under the Rules, the Returning Officer is the Australian Electoral Commission (AEC).
- The date scheduled for the AGM is 3 October 2006.
