



# Prescribed information relating to elections to be held during the year 2004 in accordance with the Rules of the Organisation

In accordance with Section 189 of the RAO Schedule, the organisation provides the following information to enable nominations to be called:

- 1. Elections are required for one National Board representative from each of the following regions:
  - New South Wales
  - South Australia
  - Tasmania
- 2. The term of office is for two years.
- 3. The reason for the elections is that the term of each incumbent is due to expire in the normal course of events.
- 4. These elections are conducted under the direct voting system.
- 5. Under the Rules, nominations for regional representatives, as defined above, must be called for not less than 50 days in advance of the date fixed for the Annual General Meeting (AGM) of the Association, and close not later than 30 days from the date of the AGM.
- 6. The date scheduled for the AGM is 8 September 2004.
- 7. Elections for the offices of National President, National Vice President and Treasurer are also required for a two-year term and, under the Rules, are conducted under the collegiate voting system. The reason is that the term of each incumbent is due to expire in the normal course of events.
- 8. Under the Rules, nominations for the respective offices of National President, National Vice President and Treasurer are to be called for within seven (7) days of the declaration of election of the three regional representatives by the returning officer forwarding a letter to all board members. Closing date for nominations shall not be less than 14 days after the date of the notice calling for such nominations.
