I would draw your attention to s233(2) and reg 147 *Schedule 1B of the Workplace Relations Act 1996* which requires notification of any alterations, certified by declaration and signed by a prescribed officer, within the prescribed period of 35 days (reg 151) after the ballot has been declared. Your prompt advice will enable the Registry to maintain a current list of office holders.
