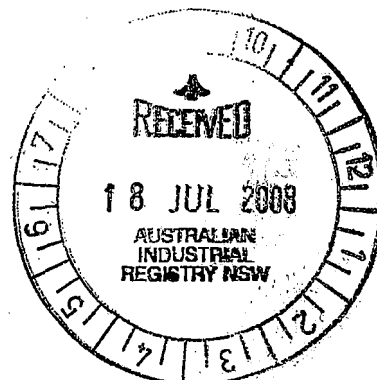
**Re: A.M.I.E.U. Office Holders**



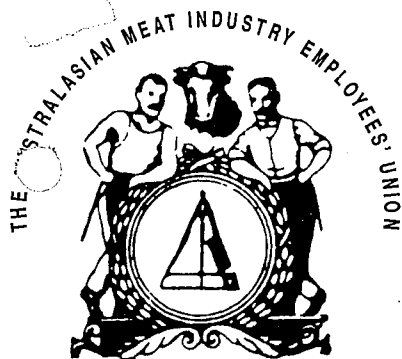
