Re: Election of AMIEU Federal Office Bearers

In accordance with subsection 189(1) of the Fair Work (Registered Organisations) Act 2009, I wish to advise the General Manager of the need to conduct an election for Federal Officers of the Australasian Meat Industry Employees' Union.

In accordance with Regulation 138 of the *Fair Work (Registered Organisations) Regulation 2009*, I am providing the following prescribed information:

(a) The name of each office or position for which an election is required:-

Federal President Federal Vice-President

(b) The reason for the election is that the term of office of these officers will expire at the 2014 Federal Council meeting of the organisation, which is to be held in Sydney on 1-5 September 2014. It is proposed that the election be conducted on 3 September 2012.

(c) The offices referred to above are singular offices. There is to be one Federal President, and one Federal Vice-President elected.

(d) The electorate for each of the offices is the Federal Council of the AMIEU. A current copy all of all such members of the Federal Council is attached.

(e) There is an ambiguity in the rules of the AMIEU as to the relevant opening and closing of nominations. No opening day of nominations is stipulated at all. Rule 17.8 suggests that nominations may be taken at the Federal Council meeting. Rule 17.9 suggests that nominations must be forwarded in writing no later than two weeks prior to the scheduled meeting.

The AMIEU therefore proposes the following timetable to avoid any difficulties:-

Opening of nominations: Immediately. Closing of nominations: 20 August 2014 [two weeks prior to 3 September 2014].

(f) There is no closing date for the roll of voters. The Federal Council is a static body elected effectively with each quadrennial Branch election. As such, the need for a closing date for a roll of voters is unnecessary.

(g) The kind of voting system to be used in the conduct of the election is a collegiate voting system.

This information is lodged under s.189(1) of the *Fair Work (Registered Organisations)* Act 2009. I certify that I am an officer of the organisation authorised to provide this information.

I request that you make arrangements for the election to be held.
