RULES

Rules used for elections Rule ID: [007V:incorporates alterations of 3/9/2015(R2015/100)]

Rules difficult to apply/interpret:

I have identified the following defects in the rules and therefore difficult to apply:

- (a) rules 17.6 and 17.7 do not apply to an election conducted by the AEC;
- (b) rules 17.8 and 17.9 are inconsistent with each other:
- (c) there is a conflict of interest in the Federal Secretary-Treasurer receiving nominations on behalf of the Federal Council in respect of the position of Federal Secretary-Treasurer if the current incumbent intends to stand for re-election.

The application made by the AMIEU to the FWC for the arrangement to conduct the election is made under section 182 of the FW(RO) Act with the consequence that rule 17.6 of the AMIEU rules does not apply to the election conducted under the arrangement. The apparent application of rules 17.6 of the AMIEU rules to the election being conducted under the arrangement is a procedural defect in the AMIEU rules.

There is an inconsistency between rules 17.8 and 17.9 in as much as the duty of the returning officer under rule 17.8 to call for nominations at the biennial meeting of the Federal Council cannot operate with the requirement in rule 17.9 for the nominations to be given to the Federal

Council no later than two weeks prior to the biennial meeting. This is a procedural defect in the AMIEU rules.

There is the further difficulty that there is an obvious conflict of interest in having the Federal Secretary-Treasurer receive nominations for the office of Federal Secretary-Treasurer. This is also a procedural defect in the AMIEU rules. Further the conflict of interest could give rise to an irregularity if the nomination of rivals for the office were not properly processed by the Federal Secretary-Treasurer.

Re: Election of AMIEU Federal Office Bearers

In accordance with subsection 189(1) of the Fair Work (Registered Organisations) Act 2009, I wish to advise the General Manager of the need to conduct an election for Federal Officers of the Australasian Meat Industry Employees' Union.

In accordance with Regulation 138 of the Fair Work (Registered Organisations) Regulation 2009, I am providing the following prescribed information:

(a) The name of each office or position for which an election is required:-

Federal Secretary
Federal President
Federal Vice-President

- (b) The reason for the election is that the term of office of these officers will expire at the 2016 Federal Council meeting of the organisation, which is to be held in Cairns on 12-15 September 2016. It is proposed that the election be conducted on 15 September 2016.
- (c) The offices referred to above are singular offices. There is to be one Federal Secretary, one Federal President, and one Federal Vice-President elected.

- (d) The electorate for each of the offices is the Federal Council of the AMIEU. A current copy all of all such members of the Federal Council is attached.
- (e) There is no opening day of nominations stipulated within our rules. Rule 17.9 provides that nominations for Federal President and Federal Vice President must be forwarded in writing to Federal Council no later than two weeks prior to the scheduled meeting. Nominations for Federal Secretary Treasurer are called for on the day of the election at the biennial meeting by the returning officer.

The AMIEU therefore proposes the following timetable to avoid any difficulties:-

Opening of nominations: Immediately. Closing of nominations: 26 August 2016 [two weeks prior to the meeting].

- (f) There is no closing date for the roll of voters. The Federal Council is a static body elected effectively with each quadrennial Branch election. As such, the need for a closing date for a roll of voters is unnecessary.
- (g) The kind of voting system to be used in the conduct of the election is a collegiate voting system.

This information is lodged under s.189(1) of the Fair Work (Registered Organisations) Act 2009. I certify that I am an officer of the organisation authorised to provide this information.

I request that you make arrangements for the election to be held.
