Dear Mr Smith,

I refer to the above election for your organisation.

Section 197(1) of the Fair Work (Registered Organisations) Act 2009 ("the Act") requires the AEC to provide a written report on the conduct of the election to Fair Work Australia and to the organisation or branch for whom the election was conducted. A copy of the report in relation to this election is attached.

Section 198 of the Act requires that if an organisation or branch is given a post election report under Section 197 that identifies a rule that was difficult to interpret or apply, the organisation or branch must, within 30 days, give a written response to the AEC on that aspect of the report. The response must specify whether the organisation or branch intends to take any action in relation to the rule, and if so, what action it intends to take.

If the attached Report identifies a rule that was difficult to interpret or apply, you should forward your response to the AEC by email to 'industrial.elections@aec.gov.au' within thirty days of the date of the report.

Section 198 and the regulations also require an organisation to make the post election report and the organisation's response to the report (if applicable) available to members.

Further, Regulation 141(4) of the Fair Work (Registered Organisations) Regulations requires an organisation or branch to publish a notice on its web site advising members that a copy of the post election report is available upon request. If a website is not available, publishing a notice in a journal or newsletter would be considered appropriate.

Re: Election of AMIEU Federal Office Bearers

In accordance with subsection 189(1) of the Fair Work (Registered Organisations) Act 2009, I wish to advise the General Manager of the need to conduct an election for the position of Federal Vice-President of the Australasian Meat Industry Employees' Union.

In accordance with Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009, I am providing the following prescribed information:

(a) The name of each office or position for which an election is required:-

Federal Vice-President

(b) The reason for the election is that the term of office expired on 15 September 2016.

Nominations for the positions of Federal Secretary Treasurer and Federal President were made and, there being a single nominee for each position, the positions were declared in advance of the AMIEU Federal Council meeting which was held in Cairns on 12-15 September 2016.

No nomination was received for the position of Federal Vice-President within the required time-frame.

That position became vacant on or about 15 September 2016 until filled in accordance with this new election.

(c) The office referred to above is singular office; there is to be one (1) Federal Vice-President elected.

(d) The electorate for the office is the Federal Council of the AMIEU. A current copy all of all such members of the Federal Council is attached.

(e) There is no opening day of nominations stipulated within the AMIEU's rules. Rule 17.9 provides that nominations for Federal Vice-President must be forwarded in writing to Federal Council no later than two weeks prior to the scheduled meeting.

The AMIEU therefore proposes the following timetable to avoid any difficulties:-

Opening of nominations: Immediately. Closing of nominations: We are content to follow any reasonable timeframe as determined by the FWC and/or AEC.

(f) There is no closing date for the roll of voters. The Federal Council is a static body elected effectively with each quadrennial Branch election. As such, the need for a closing date for a roll of voters is unnecessary.

(g) The kind of voting system to be used in the conduct of the election is a collegiate voting system.

We would respectfully request that the vote take place by postal vote, in the event that more than one (1) nomination is received. In this regard, we would note that the Federal Council is not due to meet again until September 2018.

This information is lodged under s.189(1) of the Fair Work (Registered Organisations) Act 2009. I certify that I am an officer of the organisation authorised to provide this information.

I request that you make arrangements for the election to be held.
