Dear Sir,

The elections for the Australasian Meat Industry Employees' Union (Newcastle and Northern Branch) are due. In accordance with subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009 ["the RO Act"] and prescribed information in respect of Section 138 of the RO Act, I provide the following:

(1) (a) The name of each office or position for which an election is required:

One (1) President
One (1) Vice President
One (1) Secretary
One (1) Assistant Secretary
One (1) Treasurer
Two (2) Organisers
Seven (7) Committee of Management Members
Two (2) Federal Council Delegates

(b) Reasons for the election is that;

(1) The term of the office or position referred to above has expired or is due to expire in the normal course of events under the rules of the organisation.

(c) There are no offices or positions for which an election is to be held before the prescribed day.



- (d) The electorate for the direct voting system is the whole of the Newcastle and Northern Branch.
- (e) Rule 50.1 Branch Elections provides that the Branch Elections are to be held not later than the thirty first day of December, 1969 and shall be conducted on every fourth year. The previous election was held in 2005. The election can be held in 2009 so long as it is prior to the thirty first day of December, 2009.
- (f) Rule 50.7 provides that the Returning Officer shall compile a roll of members eligible to vote pursuant to Rule 10. Rule 10.1.1 contains the provision no later than 30 days before the date fixed for the opening of nominations.
- (g) The kind of voting system to be used in the conduct of the lection is:
- (a) a direct voting system

- (2) I have attached a statement signed by me, as Secretary of the Australasian Meat Industry Employees' Union (Newcastle and Northern Branch), duly authorised to sign the statement. The information is lodged under subsection 190 (1) of the RO Act.
- (3) The prescribed information is lodged pursuant to subsection 190 (2) of the RO Act. The prescribed day being at least 2 months before a person may under the rules become a candidate in the election.

Please be advised that the Australasian Meat Industry Employees' Union (Newcastle and Northern branch) (State Registered Union) has applied to the New South Wales Industrial Registrar to conduct a separate election of the State Registered Union for similar positions. In the past the election pursuant to subsection 189 has been held simultaneously with the election of officers pursuant to the New South Wales Industrial Relations Act 1996. It would be appreciated if this could occur in the 2009 election of officers.

I request that you make arrangements for the election to be held as soon as possible.
