Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices for Newcastle and Northern Branch [E2017/110]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Australasian Meat Industry Employees' Union, The-Newcastle and Northern Branch must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;

- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Dear Sir,

The elections for the Australasian Meat Industry Employees' Union (Newcastle and Northern Branch) are due this year. In accordance with subsection 189 (1) of the Fair Work (Registered Organisations) Act 2009 ["the RO Act"] and prescribed information in respect of Section 138 of the RO Act, I provide the following:

(1) (a) The name of each office or position for which an election is required:

> One (1) President One (1) Vice President One (1) Secretary One (1) Assistant Secretary One (1) Treasurer Two (2) Organisers Seven (7) Committee of Management Members Two (2) Federal Council Delegates

Reasons for the election is that;

The term of the office or position referred to above has expired or is due to expire in the normal course of events under the rules of the organisation.

There are no offices or positions for which an election is to be held before the prescribed day.

The electorate for the direct voting system is the whole of the Newcastle and Northern Branch.

Rule 50.1 Branch Elections provides that the Branch Elections are to be held not later than the thirty first day of December, 1969 and shall be conducted on every fourth year. The previous election was held in 2013. It is my understanding the election can be held in 2017 so long as it is prior to the thirty first day of December, 2017.

Rule 50.7 provides that the Returning Officer shall compile a roll of members eligible to vote pursuant to Rule 10. Rule 10.1.1 contains the provision no later than 30 days before the date fixed for the opening of nominations.

Further the branch committee of management met on the 22nd of February 2017 and moved the following resolution

 "Moved Don Morehouse second Leonie Gibson that the branch in line with the requirements of the Fair work Act and the union rules the COM determines 2 elected organisers in the fourth coming 2017 branch Elections. Furthermore the COM directs the branch secretary to write to the FWC to call on the 2017 branch elections".
