I acknowledge receipt of your prescribed information in relation to the scheduled quadrennial election of the Queensland Branch of The Australasian Meat Industry Employees Union.

Section 189(2) of the *Fair Work (Registered Organisations) Act 2009* states that prescribed information must be lodged before the prescribed day, which under regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009* is two months before the first day when a person may become a candidate. Paragraph (e)(i) of the prescribed information states that nominations are scheduled to open on 19 July 2013. Accordingly, the prescribed day for this election is 2 months prior to 19 July 2013, which is 19 May 2013.

In this instance, given the very brief period with which the lodgment was later than the prescribed day, the Delegate of the General Manager of the Fair Work Commission has granted the election without requesting an extension of time. However, since s.189(2) is a civil penalty provision, I respectfully request that future prescribed information for elections be lodged before the prescribed day.

[1] On 20 May 2013 the Queensland Branch of The Australasian Meat Industry Employees' Union lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

[2] Section 189(2) of the *Fair Work (Registered Organisations) Act 2009* states that prescribed information must be lodged before the prescribed day, which under regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009* is two months before the first day when a person may become a candidate. Paragraph (e)(i) of the prescribed information states that nominations are scheduled to open on 19 July 2013. Accordingly, the prescribed day is 2 months prior to 19 July 2013, which on this occasion is 19 May 2013.

[3] Since s.189(2) is a civil penalty provision, I would usually require a written request for an extension of time, providing reasons for the delay in lodgement, if the prescribed information was not lodged before the prescribed day. However, considering that in this instance the lodgement was only one day later than the prescribed day, and that the prescribed information was dated before the prescribed day, I will not in the circumstances, require a written request for an extension of time.

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

(c) The Rules of the AMIEU provide (at clause 47.13) that there are to be a total of 12 committee of management representatives, in addition to the named positions – six from the Southern Region, three from the Central Region, and Three from the Northern Region. The Rules (clause 13.2.2) further specify that there are to be two Federal Council delegates elected by all of the members of the Queensland branch.

(d) The electorate for each office is as follows:

- (i) For each of the offices of Branch President, Branch Vice-President, Branch Secretary, Assistant Branch Secretary, Branch Treasurer, and Federal Council delegates, the electorate consists of the entire membership of the Queensland branch of the AMIEU [clause 47.14 of the AMIEU rules and clause 13.2.2].
- (ii) For the six committee of management representatives from the Southern Region, the electorate comprises those members of the Union who are members of the Southern Region of the Queensland Branch of the AMIEU [see clause 47.14 and 47.16 of the AMIEU rules].
- (iii) For the three committee of management representatives from the Central Region, the electorate comprises those members of the Union who are members of the Central Region of the Queensland Branch of the AMIEU [see clause 47.14 and 47.16 of the AMIEU rules].
- (iv) For the three committee of management representatives from the Northern Region, the electorate comprises those members of the Union who are members of the Northern Region of the Queensland Branch of the AMIEU [see clause 47.14 and 47.16 of the AMIEU rules].

(e) the date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation or branch in relation to the election

The Committee of Management has proposed the following timetable for the election of officers:

- (i) Opening (calling for) nominations: 19 July 2013
- (ii) Close of Nominations: 2 August 2013

(f) the rules of the AMIEU do not specifically provide for the day on which the roll of voters is to be closed;

(g) the kind of voting system to be used in the conduct of the election is a direct voting system
