[1] On 1 August 2013, the South Australian Branch of the Australasian Meat Industry Employees Union lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

[2] On 6 August 2013, the Fair Work Commission contacted the South Australian Branch of the Australasian Meat Industry Employees Union to inform them that under section 189(2) of the *Fair Work (Registered Organisations) Act 2009* (the Act) the prescribed information must be lodged before the prescribed day, and that if the prescribed information was not lodged before the prescribed day, a request for an extension of time would be required.

[3] On 7 August 2013, the South Australian Branch of the Australasian Meat Industry Employees Union lodged a written request for an extension of time for lodgment in accordance with s.189(2) of the Act.

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Dear David



Further to our telephone discussions and to your email of 5 August, in which you queried the significance of the date "31 August 2013" in my letter of 26 July. That letter was a request that the General Manager of the Fair Work Commission make arrangements with the AEC for the conduct of branch elections.

I advise that my request for branch elections to be completed by 31 August 2013 was an error. This was due to my lack of familiarity with the requirements for the conduct of elections. I have since obtained some advice from the union's national industrial officer about the process, and I can advise the following:

- The date of 31 August 2013 has no particular significance, other than I believed I needed to specify a date by which the branch wanted its elections to be conducted;
- I was under the mistaken impression that I had to have the elections for the amalgamated branch completed by October 2013, but the national industrial officer advises me that it is only necessary that the elections be completed by the end of December 2013
- It would be desirable for the branch elections for the South and Western Australian branch to be completed by 31 October 2013, but that is not essential.
- If it is possible for the branch elections to be completed by 31 October 2013, this would mean that under the rules of the AMIEU,
 - Nominations would have to close 35 days before this date, i.e. on 26 September 2013
 - Nominations would have to open 14 days before the closure of nominations, i.e. on 12 September 2013.
- If the above timeline for the election were approved, it would mean that the "prescribed day" for the lodgment of information would be two months prior to 12 September; i.e. 12 July 2103. This date has already passed. Accordingly, I would ask the General Manager to exercise his discretion that he has under *Section 189(3) of the Fair Work (Registered Organisations) Act 2013* to allow the prescribed information to be provided by a time later than the "prescribed day."

If the General Manager is not minded to exercise the discretion under Section 189(3), then it is possible for the election timetable to be altered to conform to the statutory timeframes.

AMIEU South & Western Australian Branch Elections:

I refer to the following resolution of the AMIEU South & Western Australian Branch executive meeting made on the 20th June 2013:

MOTION:

1. "THAT pursuant to Clause 50.1 of the AMIEU Rules the current terms of elected officers of the South and Western Australia Branch are due to expire.

2. THAT the South and Western Australia acting Branch Secretary apply in writing to the Fair Work Commission requesting that the Australian Electoral Commission conduct an election for all positions on the AMIEU South And Western Australia Branch Committee of Management.

Moved: J. Da Silva Seconded: S. Challenger

CARRIED UNANIMOUSLY

Pursuant to s.189(1) of the Fair Work (Registered Organisations) Act 2009 I request that South & Western Australian Branch elections be conducted before 31st August 2013 and provide the following prescribed information:

- (a) The name of each office or position for which an election is required:
- 47A.9 For the 2013 quadrennial elections and onwards, the Committee of Management of the South and Western Australian Branch shall consist of a President, a South Australian Vice President, a Western Australian Vice President, a Secretary- Treasurer, an Assistant Secretary, Organisers and the following representatives:
 - 47A.9.1 Four (4) representatives from South Australia;
 - 47A.9.2 Four (4) representatives from Western Australia;
- 47A.10 Members of the Committee of Management shall be elected as follows:
 - 47A.10.1 The Branch President, Branch Secretary, and Assistant Branch Secretary shall be elected by all the members within the Branch.
 - 47A.10.2 The South Australian Vice President shall be elected from members in South Australia.

- 47A.10.3 The Western Australian Vice President shall be elected from members in Western Australia.
- 47A.10.4 Prior to each quadrennial election, the Committee of Management must determine the number of organisers to be elected from South Australia and the number of organisers to be elected from Western Australia. Organisers shall then be elected by the members from the State they will represent.

I refer to the following resolution of the AMIEU South & Western Australian Branch committee of management meeting made on the 6th October 2012:

MOTION:

"That for the conduct of the 2013 election, the total number of organisers is to be four. This will consist of two from South Australia and two from Western Australia."

CARRIED UNANIMOUSLY

47A.10.5 The other representatives on the Committee of Management shall be elected by the members in the State they represent.
47A.10.6 The Secretary of the South and Western Australian Branch shall be based in Adelaide, and until such time as the Committee of Management determines otherwise, the Assistant Secretary of the South and Western Australian Branch shall be based in Perth.

Four (4) delegates to Federal Council as prescribed by Rule 13.2.3 of the AMIEU Rules.

(b) The reason for the election is that the term of the office or position is due to expire in the normal course of events under the rules of the organisation.

(c) There are no offices or positions to be determined before the prescribed day.

(d) The electorate comprises only eligible members of the South and Western Australian Branch of the Australasian Meat Industry Employees Union.

(e) Pursuant to Rule 50.1 Branch elections can be held during 2013 not later than the thirty-first day of December 2013. Nominations shall be called for at least fourteen (14) days before the advertised date of closing of nominations. The close of the ballot shall be thirty-five (35) days after the date set for the closing of nominations.

(f) Rule 10.1 provides for the roll of voters to be closed 30 days before the date fixed for the opening of nominations.

(g) The election is to be conducted as a direct voting system.
