I refer to the prescribed information lodged in relation to the inaugural election of the Australian Aircrew Officers Association.

I just need a little bit more documentation.

Rule 24(b)(ii) provides that the number of General Committee Members is to be determined by the General Committee at least 2 months prior to the calling of nominations. I note from the prescribed information that the number of three (3) General Committee Members has been nominated. In situations where the committee of management of an organisation can determine the number of certain offices, the Fair Work Commission has required some form of evidence that a certain number has been chosen by the committee of management.

- This election will be the inaugural election for the Australian Aircrew Officers Association.
