Post-Election Report

Australian Aircrew Officers Association Deputy Chairman Vacancy E2014/135

I refer to the above election for your organisation.

Section 197(1) of the Fair Work (Registered Organisations) Act 2009 requires the AEC to provide a written report on the conduct of the election to the Industrial Registrar and to the organisation or branch for whom the election was conducted. A copy of the report in relation to this election is attached.

Section 198 requires that if an organisation or branch is given a post-election report under section 197 that identifies a rule that was difficult to interpret or apply, the organisation or branch must, within 30 days, give a written response to the AEC on that aspect of the report. The response must specify whether the organisation or branch intends to take any action in relation to the rule, and if so, what action it intends to take.

If the attached Report identifies a rule that was difficult to interpret or apply, you should forward your response to the AEC by email to 'industrial.elections@aec.gov.au' within thirty days of the date of the report.

Section 198 and the regulations also require an organisation to make the post-election report and the organisation's response to the report (if applicable) available to members.

Further, Regulation 141(4) of the Fair Work (Registered Organisations) Regulations requires an organisation or branch to publish a notice on its web site advising members that a copy of the post-election report is available upon request. If a website is not available, publishing a notice in a journal or newsletter would be considered appropriate.

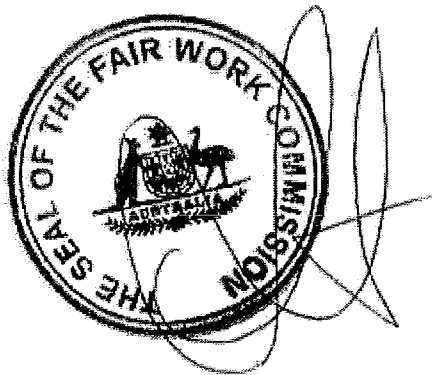

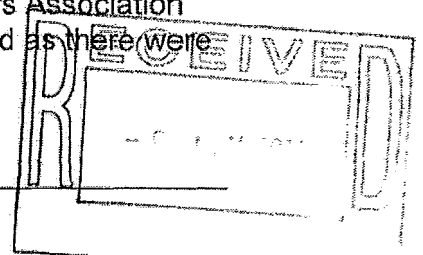

Reasons for election:

- The Australian Aircrew Officers Association was registered on 01 Oct 2013.
- In accordance with the rules of the Australian Aircrew Officers Association, the inaugural election was held no later than six (6) months following the date of registration (rule 66, i), 1).
- The inaugural election for the Australian Aircrew Officers Association did not result in the office of deputy chairman being filled as there were no nominations for this office.



Elected by:

- The election will be conducted using a direct voting system.
- The method of deciding the result of the ballot is by a first-past-the-post system (rule 39, dd).
- The electorate for the ballot is all eligible members whose name appears on the roll of voters for the ballot (rule 39, c).
- An eligible member is defined as a person who was a financial member of the Australian Aircrew Officers Association on the day that nominations open (rule 39, c).

Nominations open:

12:00 Noon on 28 July 2014

Nominations close:

12:00 Noon on 25 August 2014

Cut off date for roll:

21 July 2014 - 7 days prior to the opening date for nominations (rule 39, l), ii).

Further Information

- The ballot must remain open for not less than 21 days (rule 39, s), therefore it is intended that the ballot open no later than 01 September 2014.
- The closing day for nominations must be at least 28 days after notice is given (rule 39, e), ii), therefore it is intended that notice of the election given by no later than 28 Jul 2014.
