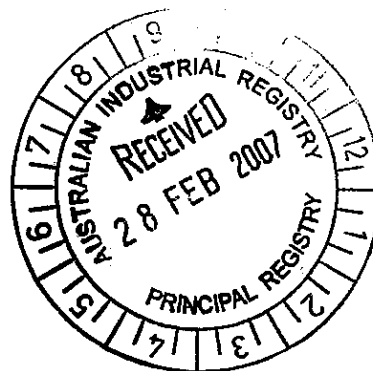




DECLARATION
