Arrangements for the conduct of an election in accordance with section 189 of Schedule 1 to the Workplace Relations Act 1996

Pursuant to Section 189(1) of Schedule 1 to the *Workplace Relations Act 1996* ("**Act**") and Regulation 138 of the Workplace Relations (RAO) Regulations, we hereby lodge the following prescribed information concerning the 2010-2012 Office Bearer elections for the Australian and International Pilots Association (**AIPA**).

Regulation 138(1)

(a) The name of each office in respect of which an election is required

- 1 President
- 3 Vice Presidents
- 1 Vice President ('A' pilots)
- 1 Secretary
- 1 Assistant Secretary
- 1 Treasurer

(b) The reason for the election

(i) With respect to the Officer Bearers, their term of office will expire (pursuant to Rule 40(a)(i)) of AIPA's Rules.

(c) The number of offices

As set out in (a) above.

(d) The electorate of each office

The electorate for the office bearer positions of President, Vice Presidents (3), Vice President ('A' Pilots), Secretary, Assistant Secretary and Treasurer, is the Committee of Management only.

(e) The date and time of the commencement and expiration of the nomination period as set out in the rules of the organisation

Nominations for office bearer positions are called as soon as possible after the result of the election for Committeemen is ascertained and wherever possible on the same day. Nominations close not less than 21 days after nominations are called (Rule 39).

(f) The day on which the roll of voters is to be closed

The roll of voters closes on the 126th day before the second Tuesday in November each year and for the current year the relevant date is **13 July 2010** (pursuant to Rule 38(a)).

(g) The voting system to be employed in the conduct of the election

The voting system for office bearer positions will be a collegiate electoral system. All elections are by secret postal ballot.

We look forward to receiving the Registrar's decision that an election for the abovenamed offices is required to be held under AIPA's Rules and advice that arrangements are being made for the conduct of the election by the Australian Electoral Commission.

Dear Iain,

I refer to our telephone discussion of earlier today.

I am writing in reference to a letter recently sent to you from Capt Steven Anderson (dated 25 June 2010), Secretary of the Australian and International Pilots Association, regarding the 2010-2011 Committee of Management Elections (your reference E2010/2614).

Fair Work Australia has confirmed the requirement for nominations and forwarded this ruling to the Australian Electoral Commission (AEC) to make the necessary arrangements to conduct the election.

Unfortunately, our initial correspondence with Fair Work Australia was incorrect and should have included a request to also conduct an Office Bearers election in addition to the Committee of Management election. As a result, it may be that the initial timeframe proposed by the AEC (for the Committee of Management election) will not be suitable given the fact that the Office Bearers election also needs to be completed within the timeframe provided for in the Rules of the Australian and International Pilots Association.

In light thereof, kindly advise us what steps are required with this regard and we trust you will inform the AEC accordingly.
