Arrangement for conduct of election.

[1] On 5 May 2021 the Australian and International Pilots Association (**the AIPA**) lodged with the Registered Organisations Commission prescribed information for an election to fill the following offices for a new term of office:

Members of the Committee of Management (20)

[2] The rules of the AIPA provide for 40 members of the committee of management, with a staggered election cycle¹ whereby these are elected in two elections of 20 committee members each.
