#### Re: AIPA Amended Officer and Related Party Disclosure Statements

We refer to our letter dated 12 June 2020 and recent correspondence with the ROC regarding related party transactions in the Australian and International Pilots Association (AIPA).

We **enclose** two amended ORP statements for the financial year ending 30 June 2018 and the financial year ending 30 June 2019.

The amended statements now include the related party transaction with AIPA and Mandoon Pty Ltd, a company controlled by Committee of Management member Andrew McCallum and his spouse. We confirm that both Andrew McCallum and his spouse are related parties under section 9B of the *Fair Work (Registered Organisations) Act 2009*. Mandoon Pty Ltd, being an entity controlled by a related party is also a related party under section 9B of the *Fair Work (Registered Organisations) Act 2009*.

In reviewing our ORP statements and preparing our amendments, we also revisited the relevant remuneration and non-cash benefits for the top five ranking of officers. In our first ORP statement, filed on 18 December 2018, AIPA classified reimbursement for lost flying as a non-cash benefit. However, in our second ORP statement filed on 20 December 2019, following conversations with the ROC and having considered the ROC's ORP guidance note GN014 dated 3 December 2019, reimbursement for lost flying was categorised as relevant remuneration. We believe that the correct categorisation is relevant remuneration. In amending the 2018 statement, we included an amendment and note to account for the correct categorisation of this reimbursement for lost flying. We apologise for this miscategorisation and we hope the changes we have made in the amended 2018 statement in this regard are acceptable to the ROC.

We once again apologise for our oversight and we appreciate the ROC engaging with AIPA to allow us to address this. As we have previously outlined to the ROC, we have instituted new measures to ensure that such an oversight will not occur in the future. We will consistently review and seek to improve our internal governance procedures to ensure that AIPA is able to achieve a high level of compliance.
