Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of contested offices for South Australian Branch [E2018/195]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Australian Education Union must notify the Commission of these changes. In particular, please advise:


- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held:
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and

• the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Fair Work (Registered Organisations) Act 2009 s.189—Arrangement for conduct of an election

Australian Education Union

(E2018/195)

MELBOURNE, 25 SEPTEMBER 2018

Arrangement for conduct of election.

[1] On 20 August 2018 the Australian Education Union (the Union) lodged with the Registered Organisations Commission (the Commission) prescribed information for an election to fill the following offices:

Queensland Branch

Federal Conference Delegate representing the General Division

South Australian Branch

Federal Conference Delegate representing the General Division

- [2] The prescribed information states that the election is due to increases in entitlements of the Union's Queensland and South Australian Branches to Federal Conference Delegates:
- [3] The Union previously lodged prescribed information for various offices, including Federal Conference Delegates representing the General Division from the Queensland and South Australian Branches on 6 April 2017. On 12 April 2017 I made arrangements for the election of these and other offices in E2017/55.
- [4] Federal Rule 24(2) provides that 'each Division in a Branch shall be entitled to one delegate for each 2,500 members assigned to each Division in the Branch or part thereof' as at 30 June of the relevant year. Federal Rule 24(3A) sets out a table that specifies the numbers.
- [5] Federal Rule 24(7) further provides that '[i]n the event that there is....an increase in the Branch's entitlement to Federal Delegates...the increased entitlement shall be filled
 - (i) where the Federal Branch Rules provide for the election of alternate Federal Delegates by the Branch Returning Officer declaring elected the alternate Federal Delegate from the relevant Division who received the highest number

- of votes before the allocation of preferences or where no election was held by determining by lot the successful candidate, or
- (ii) where the Federal Branch Rules make no provision for the election of alternate Federal Delegates by conducting an election to fill...the increased entitlement.
- [6] The Union provided the Commission with membership figures for the South Australian and Queensland Branches in support of its claim that both Branches are entitled to one additional Federal Conference Delegate representing the General Division. I accept that the increased membership numbers provided by the Union warrant the additional Federal Conference Delegates as outlined in the prescribed information.
- [7] I am satisfied that the Federal Branch Rules make no provision for the election of alternate Federal Delegates, therefore it is appropriate to conduct an election to fill the increased entitlements.
- [8] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
