

The documents have <u>not</u> been filed. The following issues must be addressed before the Annual Return can be filed:

Tasmanian Branch declaration not signed by designated officer

The Declaration provided by the Tasmanian Branch is signed by Roz Madsen, State Manager. I note that s.233(1)(b) of the RO Act requires a declaration by the secretary or other prescribed officer. Federal Rule 2 of the Australian Education Union provides that where the secretary or other prescribed officer is required to lodge documents under the Act, the prescribed officer of the Branch shall be the Branch President. As such, a Declaration by the President of the Tasmanian Branch is required.

Notification of change lodged by Queensland Branch does not meet requirements

We received on 4 June 2014 a notification from the Queensland Branch that the list of office holders had changed following the election of Ms A Lima. Unfortunately, the notification omitted the date that this change occurred. As Regulation 151 requires notification of changes to records to be submitted within 35 days of the change, it is necessary that the date of the change be included in the notification. Further, to ensure consistency with s.233(2) of the RO Act, it is suggested that the notification use the word 'declare'. An amended declaration from the Queensland Branch should be submitted as soon as possible.
