**Statement: Prescribed Information: Section 189(1) of the RAO Schedule of the Workplace Relations Act 1996**

**Two National TAFE Council Delegates representing the NSW Branch (one of whom shall be a woman).**

Reason for the Election:

This election is required to be held as a result of an increase in the NSW Branch entitlement to National TAFE Council Delegates following an increase in the Branch's TAFE Division membership at 30 June 2006 to 7,124. This gives the Branch an entitlement of 21 National TAFE Council Delegates including the TAFE Council Executive Member (the Branch currently has an entitlement to 19). The term of office of these delegates is 1 January 2007 to 31 December 2007.

Electorate:

The electorate is the TAFE Division members of the NSW Branch.

Voting System:

The voting system is a direct voting system.
