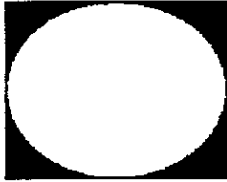

Closure of Voting Rolls


The roll of voters is closed seven days before the day on which nominations open for each of these elections.
