Statement: Amended Prescribed Information: Section 189(1) of the RAO Schedule of the Workplace Relations Act 1996

In accordance with Section 189(1) of the RAO Schedule of the Workplace Relations Act 1996 and Regulation 138, I wish to lodge the following *amended* prescribed information in relation to elections which are required to be held for the undermentioned offices in this Union. The reason for this amendment is that an election for the Queensland branch of the AEU has already been finalised – reference number E2007/277.

I am the Deputy Federal Secretary of the AEU and am authorised to lodge this prescribed information.

- 1 Federal Executive member representing the General Division of the Northern Territory Branch;
- 1 Aboriginal and Torres Strait Islander Federal Executive Member;
- 1 National Principal Federal Executive Member;
- 1 Early Childhood Educator Federal Executive Member.

The above General Division numbers are determined by the formula outlined in Rule 35(2).

Reason for the Election:

The terms of office of the above positions expire on 29 February, 2008. Those elected shall hold office for a two year term commencing 1 March 2008.

Date and Times:

Federal Rule 35 specifies the dates and times by which the elections for the above Federal Executive Member positions must be completed.

Provisions of the various Branch Rules specify the times and procedures to be followed in relation to the elections for these positions.

Electorate:

Rule 35(1)(d) states that the Executive Members representing the Branches as outlined above are "In all Branches other than the South Australian Branch and the Northern Territory Branch ... elected biennially by and from members of each Branch Council **who are assigned to the General Division**". In the case of the South Australian Branch and the Northern Territory Branch, Rule 35(1)(e) states that the Executive members are elected from the members of each Branch Executive **who are assigned to the General Division.**

Membership lists of the Branch Councils and Branch Executive in the case of the Northern Territory Branch can be obtained from the relevant Branch Secretaries. It is important for the Returning Officer to ensure that the voting roll **excludes** any member of a Branch Council or Branch Executive who is a member of the TAFE Division of the Union.

The Aboriginal and Torres Strait Islander Federal Executive member is elected jointly by and from the members of the National ATSIECS (General Division and TAFE Division). The National Principal Federal Executive Member is elected by and from the members of the National Principals Committee. The Early Childhood Educator Federal Executive Member is elected by and from the members of the National Early Childhood Committee.

The Federal Secretary will provide the membership lists of the National Committees

Voting System:

The voting system shall be a collegiate electorate system in all cases.
