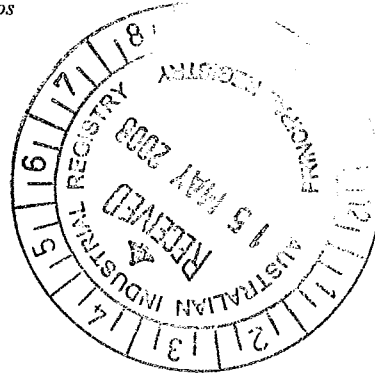

## Statement: Prescribed Information: Section 189(1) of the RAO Schedule of the Workplace Relations Act 1996

In accordance with Section 189(1) of the RAO Schedule of the Workplace Relations Act 1996 and Regulation 138, I wish to lodge the following prescribed information in relation to elections which are required to be held for the undermentioned offices in this Union.

I am the Deputy Federal Secretary of the AEU and am authorised to lodge this prescribed information.

### Name of Office:

1 Federal Executive Member representing the General Division of the Queensland Branch.  
Term of office will expire on 28 February 2010.

### Reason for the Election:

This election is required to be held as a result of the resignation of the current holder of the position, Lyn Winch (see attachment).

### Date and Times:

Federal Rule 35 specifies the dates and times by which the elections for the above Federal Executive Member positions must be completed. Provisions of the various Branch Rules specify the times and procedures to be followed in relation to the elections for these positions.

### Electorate:

Rule 35(1)(d) states that the Executive Members representing the Branches as outlined above are "In all Branches other than the South Australian Branch and the Northern Territory Branch ... elected biennially by and from members of each Branch Council **who are assigned to the General Division**". In the case of the South Australian Branch and the Northern Territory Branch, Rule 35(1)(e) states that the Executive members are elected from the members of each Branch Executive **who are assigned to the General Division**.
